## **BACKGROUND / DISCUSSION:**

Sun Metro recently completed a comprehensive review of all active procurements and contracts. During this review staff identified that the scope of services associated with the Contract 2022-0159 Wayside Signs (Brio) with Trapeze Software Group, Inc. d/b/a Vontas was limited to acquisition and installation, and software subscription for 32 wayside signs for the Montana RTS Brio. When the purchase requisition for similar signage for the Dyer Brio was processed it was erroneously linked (in People Soft) to Contract 2022-0159. The Dyer Brio signs were subsequently purchased and installed. The City Attorney's Office has determined that the issuance of the purchase order for the Dyer Brio signs constitutes a contract and given the value of the purchase it required approval of the Mass Transit Department Board. Ratification of this contracting action is now being requested.

Sun Metro has implemented a process whereby contract numbers, scopes, and capacity are verified and filed with the purchase order request when the request is submitted to the Purchasing and Strategic Sourcing Department for processing. Sun Metro has recommended to the Purchasing and Strategic Sourcing Department that they conduct similar verification when the purchase order is processed.
