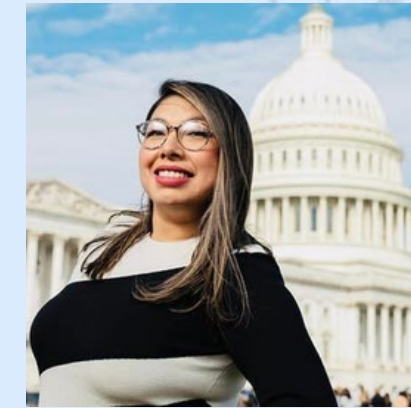

Investing in our Veterans

\$700 Million for a new El Paso VA Healthcare Center was secured in the FY22 Appropriations. Groundbreaking for this space was held on August 28th.

PACT Act:

- The largest health care and benefits expansion in VA history.
- TX-16 is home to over 48,000 veterans.
- As of July 2024, the El Paso VA has received almost 10,000 PACT Act related claims.
- Nationwide, the VA reported completion of at least 5.6 million total toxic exposure screenings.



The Dignity Act

- Congresswoman Escobar and Rep. Maria Salazar (FL) introduced the Dignity Act in May 2023.
- Currently, the bill has 37 cosponsors- 29 Democrats and 8 Republicans.

The Dignity Act accomplishes four main things:

- Opens robust legal pathways.
- Recognizes that migration happens long before migrants arrive at the border.
- Reforms border processes.
- Addresses the undocumented population in the U.S.



Why the Dignity Act Matters for El Paso

The Dignity Act:

- Manages the border by reforming outdated immigration processes
- Ensures Border Patrol agents are back out on the line instead of performing administrative tasks;
- Invests \$10 billion in infrastructure and technology at our land ports of entry; and
- Ensures El Pasoans don't shoulder the cost of housing migrants by making the Shelter and Services Program permanent

Active Shooter Alert Act of 2024

On August 12th, Congresswoman Escobar introduced the Active Shooter Alert Act of 2024.

- This piece of legislation would appoint an Active Shooter Alert Coordinator within in the Department of Justice (DOJ) and create a program similar to the AMBER Alert System for law enforcement to alert the public to active shooters in their community.
- The Coordinator would offer support and best practices to local and state law enforcement to effectively implement active shooter alert systems.

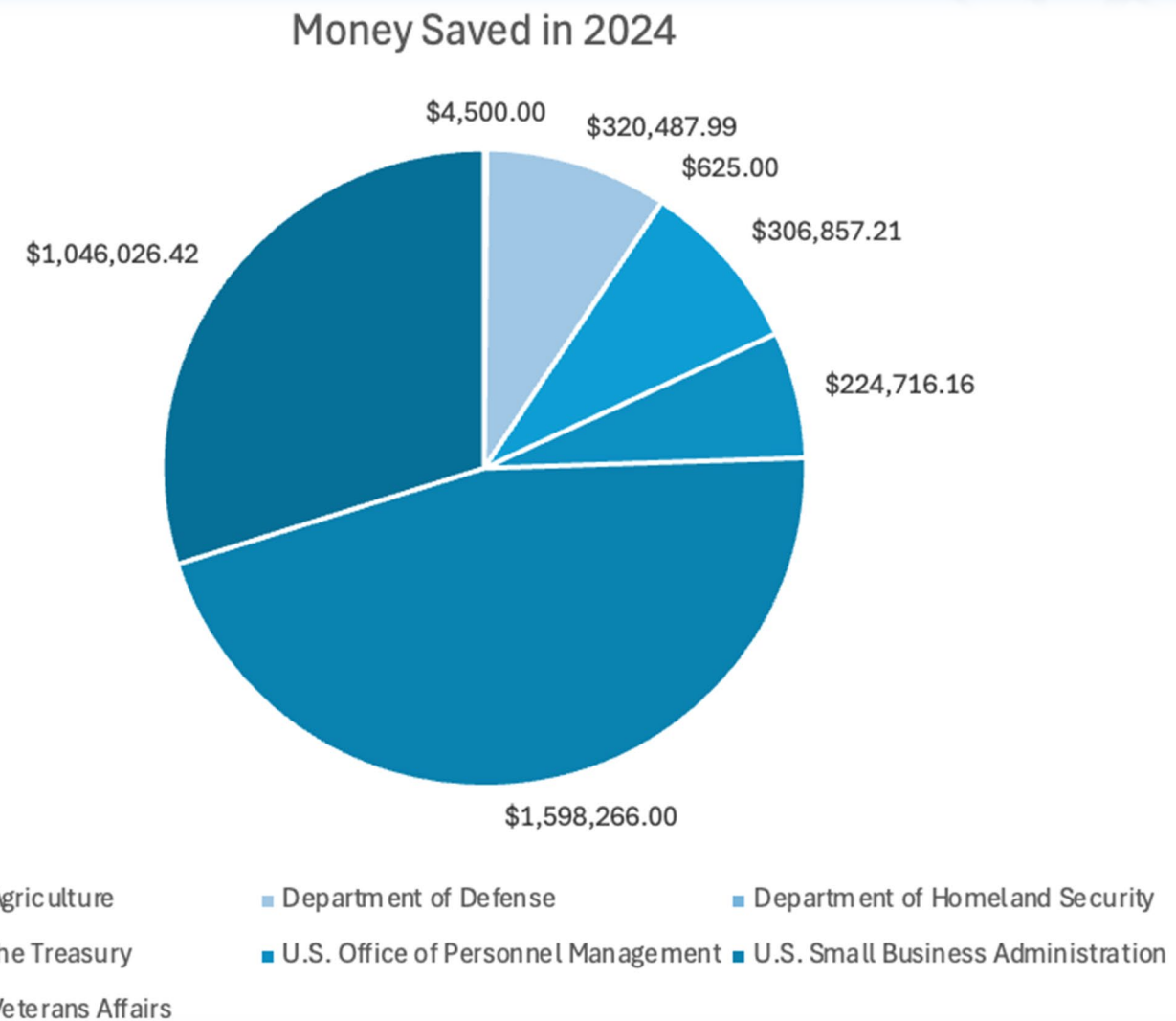

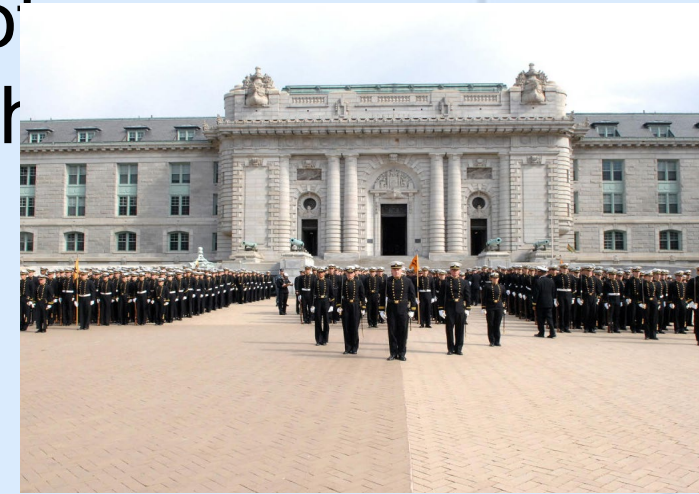
