This naming request is intended to honor Bill & Annette Means for their longstanding contributions to the City of El Paso. Bill Means previously supported the lighting improvement at Pennsylvania Park in 1990. Bill Means was a longtime El Paso resident and a prominent business owner who's projects included the remodels of the Historic Mills Building and Centre Building of Downtown El Paso. Bill Means was also involved in repairing the Mountain Star with late Electrical Engineer Andy Cook.

Annette Means was also an El Paso Native, attending Loretto Academy and UTEP. Annette Means was a criminal justice Professor at EPCC. Annette Means also dedicated her time as a member of the City Plan Commission and even was honored with the prestigious Conquistador Award in 1997.

Annette Means was also the managing partner of Mesa St Grill, which is still a staple in the city.

Bill and Annette Means moved their Family to Pennsylvania Circle in 1990, where they personally cared to preserve the beauty of the neighborhood, In 1990 Bill Means would personally fund the new lights, irrigation system and the reseeded of the grass to maintain the neighborhoods unique historical charm.

Annette Means passed away in the summer of 2009 and Bill Means followed January of 2019.

I feel honored to request the renaming of Pennsylvania Park, which was part of their neighborhood for many years.

Everyone that knew Bill and Annette Means personally can attest to their tremendous love for El Paso and how they held their civic duty with such high regard and dignity. This is one of many reasons I propose renaming Pennsylvania Park to Bill & Annette Means Park, they were inseparable since they cited their vows, naming the park without both of their names present would not represent the couple they were.
