What's a Foreign Trade Zone (FTZ)?

A Department of Commerce business support tool, where foreign goods can be brought into the United States without the need to pay Customs duties

Cities are asked by Department of Commerce to manage program



El Paso FTZ – What we are not

- FTZ's do not impact city property taxes
- FTZ's do not impact residential and retail property



El Paso Foreign Trade Zone Benefits to the City

El Paso FTZ:

- 707 jobs because of FTZ (annual company reported data)
- 3400 acres
- \$6B in dollars moving through the FTZ annually

Company retention and expansion in El Paso

- 30 companies
- \$3.2B value add annually, to the businesses located in the FTZ
 - Lease costs, wages, utilities, insurance

Business Incentive – facilitates company growth

• Increase City tax base



El Paso FTZ – Why Businesses Care

Companies operating the Foreign Trade Zone program are able to eliminate or reduce

- Customs Duties on goods
- Merchandise Processing Fees
- Customs Brokers Fees
- Insurance and Bond Costs



Average Company Saves \$0.20 on the Dollar in Foreign Trade Zone





EP Foreign Trade Zone Costs

30 Companies pay \$450K in fees per year for FTZ benefits

- 15 companies pay \$20k per year
- 15 companies pay \$10K per year

City employs FTZ team through ELP

- Costs are \$400K
- But, costs are less than revenue


