ORDINANCE NO.	

AN ORDINANCE AMENDING TITLE 15 (PUBLIC SERVICES), CHAPTER 15.22 (WATER AND WASTEWATER IMPACT FEES), BY ADDING SECTION 15.22.200 (EXEMPTIONS) IN ORDER TO COMPLY WITH THE UPDATED REQUIREMENTS IN ACCORDANCE WITH SENATE BILL 840 OF THE TEXAS 89TH LEGISLATIVE SESSION.

WHEREAS, Senate Bill 840 ("SB 840") was enacted on May 28, 2025 by the Texas 89th Legislative Session, with an effective date of September 1, 2025; and

WHEREAS, SB 840 seeks to increase the housing stock and housing options within Texas; and

WHEREAS, this Ordinance amends Title 15 (Public Services) of the El Paso City Code to comply with SB 840.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO, TEXAS THAT:

<u>Section 1.</u> That Title 15 (Public Services), Chapter 15.22 (Water and Wastewater Impact Fees) is amended to add the following section:

15.22.200 Exception.

An impact fee shall not be collected on land where a building has been converted to mixed-use residential or apartment use as defined in El Paso City Code Title 20 unless the land on which the building is located was already subject to an impact fee before a building permit related to the conversion was filed with the municipality.

<u>Section 2.</u> Except as herein amended, Title 15 (Public Services) of the El Paso City Code shall remain in full force and effect.
