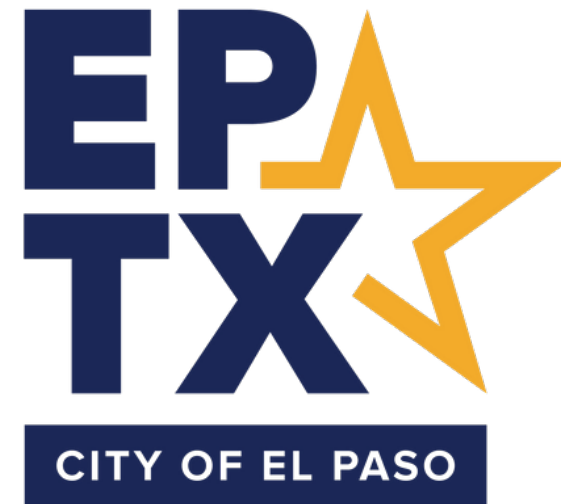

SMART

Strengthening Mobility and Revolutionizing Transportation (SMART)

The Bipartisan Infrastructure Law (BIL) established the **SMART Grants Program with \$500,000,000**, including \$100,000,000 for FY 2024.

Stage 1 Planning and Prototyping:

- \$50,000,000 for Stage 1
- 30 Stage 1 grants of up to \$2,000,000 per award

Stage 2 Implementation:

- Only recipients of Stage 1 grants are eligible to apply for Stage 2
- Up to \$15,000,000 for implementation

2. Design integration of Ysleta and BOTA Ports ITS

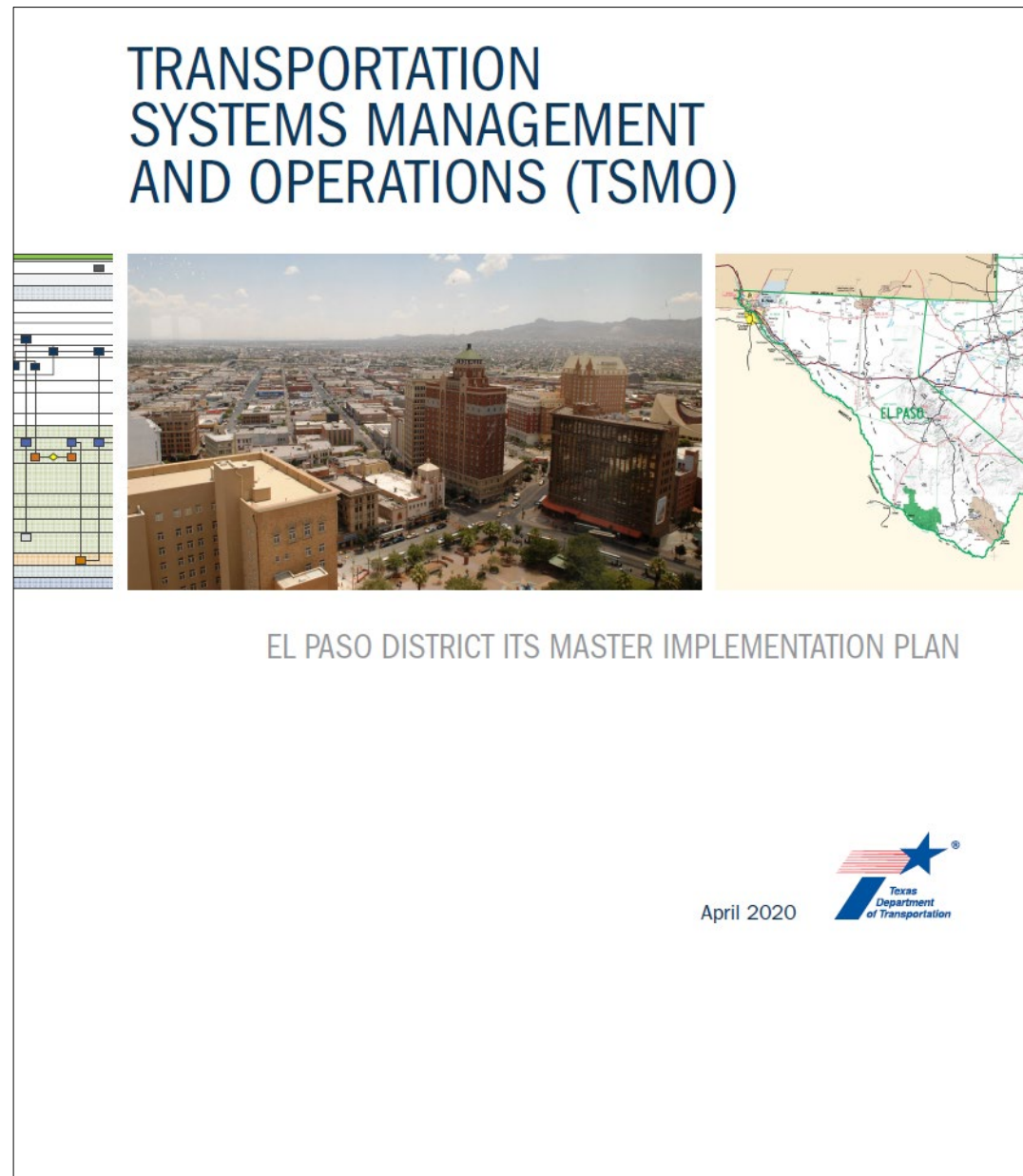

Project Budget

Project Components	Grant
ITS System Design	\$1,500,000
ITS Integration	\$500,000
Total	\$2,000,000

- **No City match is required**
- ITS System Design budget is based on recent costs for Ysleta and BOTA ITS design (\$32M State Rider)
- ITS integration will be sub-granted to Project Partners. Integration includes [PDN Uno](#) **PDN Uno**

Impact to City

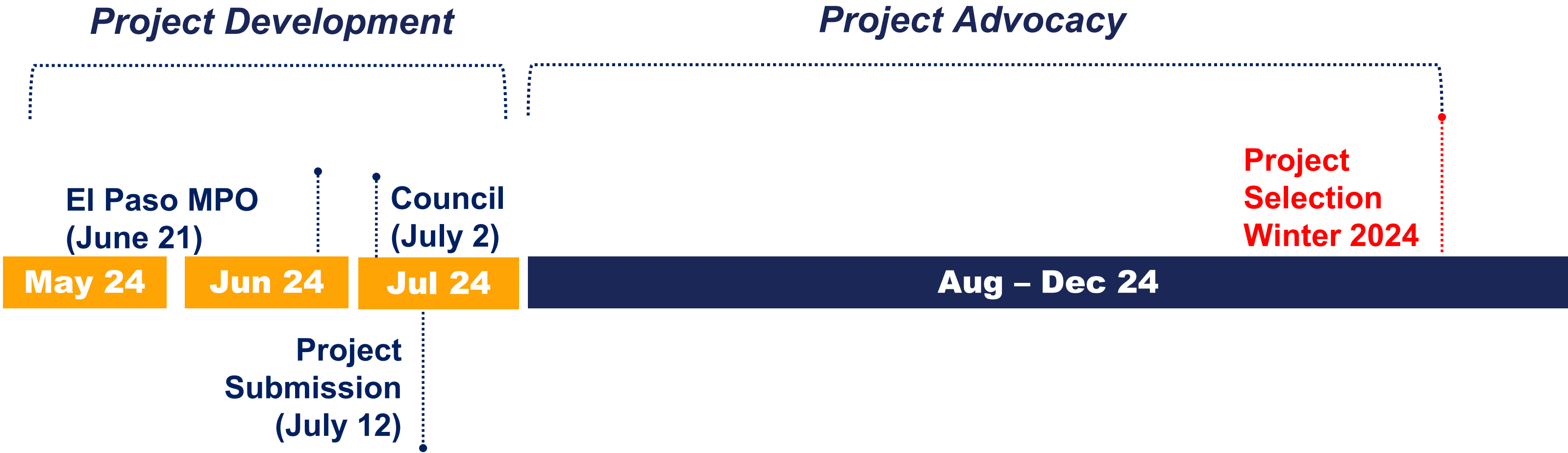
This SMART Project will **improve efficiency** for nationally-significant trade infrastructure, **reduce greenhouse gas emissions**, and **improve the flow of traffic** along priority transportation corridors.

Additional benefits include:

- Modernizing City-owned assets
- Leveraging \$32M in state funding for ITS for Ysleta and BOTA ports
- Supporting a regional response to future closures of commercial traffic lanes at BOTA (part of a \$700M federal investment)
- Improve emergency response capacity at and near international ports
