BACKGROUND / DISCUSSION:

The Application involves completing transportation and green infrastructure improvements, stormwater pollution and air quality monitoring, and workforce development programs with measurable reductions to greenhouse gas emissions in the MCA Campus. Infrastructure improvements include campus complete streets and sidewalk improvements and extensions of Dailey Street and Frutas Street. The Project will be performed in partnership with the UT Houston School of Public Health, Neighborhood Associations, EPISD, and other public, private, and nonprofit agencies. The Project will implement strategies included in the MCA Master Plan, the Onward Alameda Master Plan, the Vision Zero Plan, and the Preliminary Climate Action Plan (PCAP).
