



I. Introduction and Purpose

The Strategic and Legislative Affairs (SLA) Department serves as the City of El Paso's main link to federal, state, international, and regional partners. SLA coordinates the City's work with our State Delegation and state agencies to advance City Council priorities, protect municipal authority and resources, and secure funding that benefits El Paso residents.

The State Legislative Agenda for the 90th Session outlines the priorities that will drive the City of El Paso's work at the Capitol. The Agenda directs the Strategic and Legislative Affairs Department, City departments, and consultants to develop legislation, testify in committees, respond to proposed legislation, and pursue state resources. The Mayor, as the City's intergovernmental representative, will provide additional direction to the Strategic and Legislative Affairs Team on the City's position regarding specific legislation.

Agenda Implementation Actions

SLA will work with the Mayor and City Council to:

- Create opportunities for the Mayor and City Council to provide testimony to the State Legislature, serve on state committees, and engage directly with State Agencies
- Coordinate with the Mayor and City Council to receive resolutions and recognitions from the State Legislature on behalf of the citizens of the City of El Paso

SLA will support City Departments in navigating the 90th Legislative Session by:

- Advancing City Council directives through clear, consistent messaging
- Developing position statements in coordination with the City Attorney's Office
- Commenting on state legislation that affects City programs and services
- Responding to changes in state rules and guidance published in the Texas Register
- Participating in public comment opportunities and stakeholder processes

SLA will support City Departments in securing new state funding opportunities by:

- Pursuing increased funding for Police, Fire, and Veterans services
- Seeking additional funding for critical infrastructure and transportation projects
- Advancing state funding for advanced manufacturing, aerospace, and defense-related initiatives in alignment with the City strategic plan

SLA will advance legislation that:

- Expands Hotel Occupancy Tax tools to support tourism, convention center facilities, and major events
- Obtains necessary state approvals for international bridge projects, including the Ysleta-Zaragoza Port of Entry Presidential Permit
- Implements City department priorities to improve programs, strengthen local funding tools, and enhance service delivery

SLA will build and maintain strong partnerships by:

- Working directly with the State Delegation to advance the Legislative Agenda
- Collaborating with El Paso County, other municipalities, UTEP, school districts, nonprofits, and the private sector to align and advance shared legislative goals
- Overseeing and aligning the City's state lobbying services with Council priorities and the Strategic Plan
- Participating in and actively engaging with TML committees to ensure El Paso's priorities are represented at the Capitol
- Actively engaging with other Texas border cities and international representatives

Appendix II. Bill Tracking and Post Session Adoption

Bill Tracking and Response

Strategic and Legislative Affairs (SLA) will track state legislation and administrative actions that may affect the City of El Paso's authority, fiscal position, operations, and strategic priorities. Bill tracking will support timely decision making, coordinated City positions, and effective advocacy during the 90th Texas Legislative Session.

SLA will track bills impacting the City of El Paso by:

- Maintaining a centralized tracking system using contracted third-party software and internal tools to log bill summaries, status updates, key deadlines, committee actions, and preliminary risk and opportunity flags, and ensuring that all bills including those flagged by SLA staff and the City's state lobbyist, are reviewed in partnership with the City Attorney's Office before the City takes a support or oppose position
- Categorizing tracked bills by policy area and impact level, including fiscal impact, department-level operational impact, and preemption risk
- Requesting support from City Attorney's Office on drafting and reviewing support/opposition statements on filed bills, documenting non-action on bills, and performing a rapid review of late filed substitutes and amendments that may alter bill impacts
- Maintaining a record of City positions and advocacy actions to support transparency, continuity, and post session implementation planning

SLA will provide regular updates to City Council, City Leadership, City Attorney's Office, and City Departments by:

- Coordinating daily and weekly legislative monitoring with the City's state lobbyist and the Texas Municipal League (TML) to identify filed bills, committee referrals, hearings, amendments, and floor activity that may require City attention
- Providing weekly notifications and reports to the City Attorney's Office and City Departments, including anticipated timelines and requested department input
- Sending regular Memos to the Mayor and City Council summarizing major issues, high-profile legislation, and opportunities to comment and testify

Post Session Bill Adoption and Implementation Support


SLA will support City Departments in implementing legislation enacted during the 90th Session by:

- Preparing a post session legislative brief for City Council and City Departments
- Communicating bill adoption deadlines, effective dates, and compliance requirements in coordination with the City Attorney's Office, including rulemaking timelines and agency guidance
- Communicating to City Departments any required City actions such as ordinance updates, policy changes, interlocal agreements, procurement adjustments, staffing impacts, and reporting requirements, in coordination with the City Attorney's Office
- Estimating fiscal impacts and budget actions in coordination with the Office of the Comptroller, including anticipated revenue changes, cost increases, changes to match requirements, and funding opportunities created by new law
- Supporting City Departments in engaging state agencies on implementation details, including drafting comments, participating in stakeholder processes, and requesting technical assistance where appropriate

Appendix III. Rider Requests

Rider Request: \$25M for I-10 Deck Plaza

The City of El Paso will request a \$25 million appropriation for the I-10 Deck Plaza project in coordination with the Office of Senator Blanco and all members of the State Delegation. Funding will be used to construct the Deck Plaza and will be used in coordination with other local, state, and federal funds allocated to the project.



Rider Request: \$10M for Ysleta-Zaragoza Port of Entry

The City of El Paso will request a \$10 million appropriation for the Ysleta-Zaragoza Port of Entry project in coordination with the Office of Senator Blanco and all members of the State Delegation. Funds will be used for construction activities that implement roadway and access modifications supporting commercial vehicle movements, upgrades to City and Texas DPS facilities and operations, and related site, utility, and traffic control work necessary to deliver the project in compliance with federal requirements.



Rider Request: \$10M for the Advanced Manufacturing District

The City of El Paso will request a \$10 million appropriation for the Advanced Manufacturing District Project. Funds will be used for construction of the AMD's enabling infrastructure and initial facilities needed to support space, aerospace, defense, and dual use manufacturing, including site preparation, grading, drainage, internal access and circulation, water and wastewater extensions, electric power distribution and redundancy, fiber, lighting and security, and the initial shared use industrial warm shell and common area improvements that allow rapid tenant occupancy.



Appendix IV. Senate Interim Charges

Proposed Interim Charge 1: Evaluating Statewide Water Supply and Data Center Demand

The Committee shall conduct a statewide analysis of the near-term and long-term impacts of large load facilities, including data centers and artificial intelligence compute campuses, on Texas water supply planning and drought resilience. The study shall include freshwater and non-potable sources, including brackish groundwater, reclaimed water, and desalination, and shall evaluate impacts across all Regional Water Planning Areas.

The Committee shall:

1. Inventory current and planned data center development in Texas, including location, expected capacity, commissioning timelines, cooling technology assumptions, and associated water demands, with the analysis structured by Regional Water Planning Area, river basin, and aquifer where practicable.
2. Evaluate water use profiles by cooling approach, including chilled water systems, evaporative cooling, hybrid systems, and emerging low water technologies, and quantify water intensity ranges under Texas climate conditions.
3. Identify water supply risks and pinch points tied to drought of record scenarios, including risks to municipal supply, agriculture, and industrial users, and assess potential impacts on environmental flows and groundwater sustainability.
4. Review existing statutory authorities, permitting pathways, and reporting requirements relevant to industrial water use, groundwater production, reuse, and discharge, and identify gaps in transparency, metering, and demand forecasting for large load facilities.
5. Develop legislative recommendations to ensure that data center water demand is incorporated into statewide and regional water planning, including recommendations on data collection standards, confidentiality limits, and a consistent methodology for forecasting industrial water demands.

Proposed Interim Charge 2: Direction to the Texas Water Development Board on Forecasting and Planning Integration

The Committee shall study whether existing statewide and regional water planning processes adequately capture rapid load growth from large load facilities, including data centers, and shall evaluate statutory and administrative options to strengthen the Texas Water Development Board's ability to model, forecast, and publish water demand estimates tied to these facilities.

The Committee shall:

1. Direct the Texas Water Development Board to propose a standardized statewide methodology for estimating and validating water demand associated with large load facilities, including assumptions for cooling technology, climate, operational intensity, and onsite reuse.
2. Direct the Texas Water Development Board to recommend how these demand projections should be incorporated into the State Water Plan, the Regional Water Plans, and associated planning datasets, including guidance to Regional Water Planning Groups.
3. Evaluate options for improving the timeliness and accuracy of industrial demand updates between formal planning cycles, including annual or biennial refresh mechanisms and triggers tied to interconnection requests, building permits, tax incentive applications, or other verifiable indicators.
4. Evaluate how state financing programs and technical assistance programs administered by the Texas Water Development Board can better support non-potable and alternative water supplies for large load facilities, including reclaimed water expansion, brackish groundwater development, aquifer storage and recovery, and desalination where appropriate.
5. Identify legislative recommendations to strengthen coordination among the Texas Water Development Board, relevant state agencies, and local water providers to ensure that water supply strategies are aligned with large load growth.

The Committee shall request the Texas Water Development Board to deliver:

1. A written statewide assessment summarizing current and projected large load water demands through 2080.
2. Recommended statutory changes, if any, needed to implement an ongoing forecasting and planning integration framework.
3. A proposed data reporting template for large load facilities that supports planning while protecting bona fide proprietary information.

Appendix V. Proposed Legislation

Draft Legislation: Establishing Project Financing Zone (PFZ) eligibility and applicability for projects in El Paso

Legislative model reference: [Texas Tax Code Chapter 351.1015 \(b\)](#) | [S.B. 1057 \(88R\)](#), [Texas Tax Code Section 351.1015](#)

The intent of this legislation is to expand Project Financing Zone (PFZ) eligibility for qualified projects in El Paso utilizing the population applicability criteria and proposing this as bracketed legislation via proximity to the U.S.-Mexico border. This draft legislation language was submitted to the Office of Senator Blanco for review and amendment.

AN ACT

relating to the eligibility of certain international border municipalities to use project financing zone revenue for a convention center facility and related infrastructure.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 351.1015(b), Tax Code, is amended by adding Subdivision (1-a) to read as follows:

(b) This section applies only to a qualified project located in:

(1) a municipality with a population of at least 650,000 but less than 750,000 according to the most recent federal decennial census; or

(1-a) a municipality that:

(A) is located on an international border.

SECTION 2. Section 351.1015, Tax Code, is amended by adding Subsection (b-1) to read as follows:

(b-1) A qualified project located in a municipality described by Subsection (b) (1-a) includes a convention center facility and related infrastructure, as those terms are used in this chapter, when the municipality designates a project financing zone under this section.

SECTION 3. APPLICABILITY. This Act applies to a project financing zone designated on or after the effective date of this Act.

SECTION 4. EFFECTIVE DATE. This Act takes effect September 1, 2027.

Draft Legislation: Modifying Project Financing Zone (PFZ) Boundaries for projects in El Paso

Legislative model reference: [Texas Tax Code Chapter 351.1015 \(a\) \(4\)](#) | [S.B. 1250 Senate Research Center 89R9927 CJD-F](#)

The intent of this legislation is to enable modified Project Financing Zone (PFZ) boundaries for qualified projects in El Paso. The proposed PFZ boundary for the El Paso Convention Center maintains a contiguous area not exceeding the maximum area of a three-mile radius and contains a qualified project. This draft legislation language was submitted to the Office of Senator Blanco for review and amendment.

AN ACT

relating to the definition of a project financing zone for certain municipalities when a standard three-mile radius extends beyond the jurisdictional boundary of the municipality due to an international border.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 351.1015(a) (4), Tax Code, is amended to read as follows:

(4) "Project financing zone" means an area within a municipality:

(A) that the municipality by ordinance or by agreement under Chapter 380, Local Government Code, designates as a project financing zone;

(B) the boundaries of which are:

(i) within a three-mile radius of the center of a qualified project; or

(ii) if designated by a municipality described by Subsection (b) (1-a), a contiguous geographic area the total area of which is less than or equal to the maximum area allowed under Subparagraph (i) that:

(a) is located within the territorial jurisdiction of the municipality; and

(b) contains the qualified projects;

(C) the designation of which specifies:

(i) for a zone the boundaries of which are prescribed by Paragraph (B) (i), the longitude and latitude of the center of the qualified project; or

(ii) for a zone the boundaries of which are prescribed by Paragraph (B) (ii), the exact boundaries of the zone; and

(D) the designation of which expires not later than the 30th anniversary of the date of designation.

SECTION 2. Section 351.1015, Tax Code, is amended by adding Subsection (a-1) to read as follows:

(a-1) A municipality described by Subsection (b) (1-a) may designate a project financing zone under Subsection (a) (4) (B) (ii) if any portion of the three-mile radius described by Subsection (a) (4) (B) (i) extends along the international boundary of the United States in El Paso County.

SECTION 3. APPLICABILITY. This Act applies to a project financing zone designated on or after the effective date of this Act.

SECTION 4. EFFECTIVE DATE. This Act takes effect September 1, 2027.
