Discussion and action on the award of solicitation 2026-0095 - 2025 Collector & Arterial Street Resurfacing to International Eagle Enterprises a term of seven hundred thirty (730) consecutive calendar days for an estimated amount of \$35,427,150.00.

BACKGROUND / DISCUSSION:

This contract supports the City of El Paso's ongoing street resurfacing program and provides for the milling and paving of various collector and arterial streets within the City right-of-way. Under task orders issued by the Streets and Maintenance Department, the selected contractor will perform asphalt rehabilitation on designated roadways. The scope of work may also include repairs to base failures, or other roadway conditions identified during construction and repairs to concrete structures within the right of way as needed. Task orders may be funded from multiple sources and will support a range of projects, from routine resurfacing to expedited, fast-track assignments.

COMMUNITY AND STAKEHOLDER OUTREACH:

A pre-proposal meeting was held on September 17, 2025. Three (3) suppliers were in attendance.

SELECTION SUMMARY:

Solicitation was advertised on September 9, 2025 and September 16, 2025. The solicitation was posted on City website on September 9, 2025. There were a total forty-five (45) viewers online; five (5) proposals were received; three (3) from local suppliers.


