1. For presentation and discussion: FY 2026 - 2027 Budget as presented by the City Manager.

Department Budget Profiles

The second day of the budget workshop commenced with the continuation of the City departments' preliminary presentations for the Fiscal Year (FY) 2027 budget. Departments presented their proposed budgets, highlighted key operational priorities, outlined anticipated expenditures and funding needs, and responded to questions and feedback from the Mayor and City Council as part of the ongoing budget review process.

The presentation outlined the preliminary FY 2027 budget proposals for a wide range of City of El Paso departments, highlighting each department's mission, proposed funding levels, major budget variances, key programs, and alignment with the City's Strategic Plan. Most departments reported budget increases primarily driven by salary adjustments, inflationary pressures, contractual obligations, and operational costs, while several also reflected staffing changes, grant fluctuations, or organizational restructuring. Throughout the presentation, departments emphasized responsible stewardship of public funds while maintaining or expanding services that support public safety, quality of life, economic mobility, infrastructure, and good governance.

Several departments presented initiatives focused on improving services and addressing community priorities. The Public Library highlighted literacy programs, Career Online High School, family programming, and services for young adults. Municipal Court emphasized expanded customer service, flexible payment options, court navigation, and improved technology. Museums and Cultural Affairs focused on educational programming, exhibitions, creative sector investments, and signature events, while Parks and Recreation outlined investments in parks, recreation centers, aquatics, sports, senior programming, and maintenance of public spaces. Planning & Inspections, Real Estate, Urban Planning & Design, and Strategic Communications concentrated on streamlining permitting, improving property management, increasing housing opportunities, strengthening public engagement, and enhancing communication with residents.

The presentation also highlighted significant investments in essential public services and core government operations. The Police Department, Public Health Department, Streets & Maintenance, Sun Metro, Office of the Comptroller, Purchasing & Strategic Sourcing, Tax Office, Zoo, Strategic & Legislative Affairs, and the City Manager's Office each outlined initiatives to improve operational efficiency, financial accountability, infrastructure maintenance, public transportation, emergency response, health services, procurement, tax administration, conservation, legislative advocacy, and strategic planning. Across all departments, the proposed FY 2027 budget emphasized measurable performance outcomes, modernization of operations, data-driven decision-making, and continued delivery of high-quality services while aligning departmental goals with the City's long-term strategic priorities.
