ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE 2 (ADMINISTRATION AND PERSONNEL), TO REMOVE CHAPTER 2.72 (COMMITTEE ON BORDER RELATIONS) TO REMOVE REFERENCES AND LANGUAGE REGARDING THE COMMITTEE ON BORDER RELATIONS IN ITS ENTIRETY.

WHEREAS, the El Paso City Council establishes City Boards and Commissions to inform City Council under statutory authorization or on particular issues or subjects of interest to the Council; and

WHEREAS, the City of El Paso recognizes the importance of consistent governance and operational procedures across all city boards and commissions to ensure efficient and effective public administration; and

WHEREAS, on May 12, 2025, City Council directed boards and commissions be standardized to be enacted by resolution instead of ordinance; and

WHEREAS, by Ordinance No. 018789, the El Paso City Council created the Committee on Border Relations (the "Committee") to serve as an advisory committee for the purpose of making recommendations to the City Council and the binational task force or successor entity of the latter on programs or projects to enhance and benefit the relations between the City of El Paso and Ciudad Juarez; and

WHEREAS, the El Paso City Council wishes to repeal the Ordinance enacting the Committee as a Resolution will be adopted in its place.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

SECTION 1. That Ordinance No. 018789 be repealed in its entirety.

SECTION 2. That El Paso City Code Title 2, Chapter 2.72 is hereby deleted to read as follows:

Chapter 2.72 – Reserved.

SECTION 3. Except as expressly herein amended, all other provisions of the El Paso City Code will remain in full force and effect. Any provision of this ordinance deemed illegal will be severed and the remainder will remain in effect. The requirements of this ordinance will take effect 90 days from its adoption and publication in accordance with and as provided by law and the City Charter.


