

## **Change Order Scope of Work**



- Basic electrical requirements including electrical demolition and relocation work
- Directional Boring
- · Airport lighting systems
- Approach lighting systems
- Underground power cable for airports, duct banks, and conduits
- Electrical manholes and junction structures
- Preparation/Removal of existing pavements
- Drainage Improvements
- · Clearing and grubbing



### **Strategic Advantages**

Change Order results in an increase of safety aircraft operations, reducing unsafe conditions, and cost savings to project area by:

- Reducing the Runway 8R/26L closures by 24 days in future project phases
- Cost Savings of \$99,942.00 to project area due to elimination of rework

Closure to Runway 8R/26L leaves only 1 commercial runway available for aircraft operations and causes back-taxi movements on airfield

- Aircraft back-taxi operations create unsafe aircraft movements and causes delays and congestion
- Back-Taxi on an active runway also results in increased risk of runway incursions due to aircraft traveling against normal traffic flow
- Fewer disruptions to normal runway operations, streamline air traffic management and improve overall airport efficiency



### **Recommended Council Action**

That the City Manager be authorized to approve the change order for a project located at the El Paso International Airport by and between the City of El Paso and Jordan Foster Construction for a project known as "EPIA Relocation of Taxiway M", for an amount not to exceed two hundred fifty one thousand, nine hundred ten and 40/100 dollars (\$251,910.40). That the City Manager is authorized to establish the funding sources and make any necessary budget transfers and execute any and all documents and contracts necessary for execution of the Agreement.
