CITY COUNCIL WORK SESSION MINUTES January 18, 2022 COUNCIL CHAMBERS, CITY HALL AND VIRTUALLY 9:05 A.M.

The City Council of the City of El Paso met at the above place and date. Meeting was called to order at 9:17 a.m. Mayor Oscar Leeser was present and presiding and the following Council Members answered roll call: Peter Svarzbein, Joe Molinar, Isabel Salcido, Claudia Rodriguez, Henry Rivera, and Cissy Lizarraga. Alexsandra Annello and Cassandra Hernandez joined via videoconference. Early departure: Isabel Salcido at 3:40 p.m. NOTE: The meeting was reconvened on January 19, 2022 with all members

1. Presentation and discussion by the COVID-19 Response and Recovery Cross-Functional Team providing information on key activities, efforts, and processes.

1. Overview (Tommy Gonzalez)

present except Isabel Salcido who requested to be excused.

Mr. Tommy Gonzalez, City Manager, began the presentation by explaining that number of new COVID-19 cases were exceeding 1,000 daily and hospitalizations were on the increase, thus causing a strain on the healthcare system, similar to the rest of the nation. Mr. Gonzalez added that 60% of these cases were breakthrough cases and explained that while the Omicron strain was more contagious, it was not as deadly. He emphasized the need to protect ourselves by using safeguards. Mr. Gonzalez stated that we are still leading the nation in vaccination rates with 33% of the 16-year-olds and older population fully vaccinated and 67% of 5-year-olds and older fully vaccinated, and now 12-year-old children eligible for boosters. He said the demand for testing reduced from 17,000 to 4,000 and added there are extended hours of operation at testing sites.

Ms. Karla Nieman, City Attorney, continued the presentation and provided information on the proposed amendment to the emergency ordinance allowing certain boards and commissions to meet virtually unless required to meet in person by state law.

In regards to the mask mandate litigation, there was no update, however, in Harris County the court ruled against the Governor. Ms. Nieman ended the presentation by mentioning that the State Court of the United States had blocked the vaccine mandate on January 13, 2022, for employers with more than 100 employees but upheld the mandate for healthcare workers at facilities accepting Medicare/Medicaid.

3. Team Lead Report:

a) Health Focus (Hector Ocaranza, M.D.)

Dr. Hector Ocaranza, Public Health Authority, continued the presentation by highlighting a sharp increase in cases due to the Omicron variant. He recommended testing, and staying home if symptomatic, and mentioned that detailed guidelines were posted on the EPSTRONG website. Dr. Ocaranza explained that some positive results were reported from at home testing and added that breakthrough infections were milder than the Delta variant. He mentioned that even though the number of hospitalizations were increasing, the booster vaccines were keeping people out of the hospital. Dr. Ocaranza mentioned that he was working closely with schools to provide recommendations for keeping kids safe given pediatric cases were also on the rise particularly among middle to high-school-age children.

4. City Manager Wrap-up (Tommy Gonzalez)

Mr. Gonzalez closed the presentation by restating that although the Omicron variant was not as severe as Delta, he encouraged following protocols such as healthy living, use of face masks, social distancing, hand washing, therapeutics and quarantining for 5 days if infected.

2. RESOLUTION

WHEREAS, on March 13, 2020 the President of the United States declared a national emergency, Governor of the State of Texas declared a state of disaster, and the Mayor of the City of El Paso declared a local state of disaster in relation to Coronavirus Disease 19 (COVID-19); and

WHEREAS, on March 17, 2020 City Council issued an Emergency Ordinance Instituting Emergency Measures due to a Public Health Emergency ("Emergency Ordinance"); and

WHEREAS, on May 11, 2020 City Council approved appropriations for the CARES Act funds received by the City for eligible expenses from March 1, 2020 through August 31, 2021; and

WHEREAS, the City has on going COVID-19 related expenditures that have continued into FY 2022; and

WHEREAS, the COVID-19 pandemic is a public health crisis that has required immediate action from the City to relieve the emergency necessity of the municipality's residents and to protect the health and safety of the community, resulting in expenditures by the City to respond to the COVID-19 public health emergency; and

WHEREAS, on March 11, 2021, the federal government enacted the American Rescue Plan Act ("ARPA") which established the Coronavirus State Fiscal Recovery Fund and Coronavirus Local Fiscal Recovery Fund ("CSLFRF); and

WHEREAS, the City is a recipient of ARPA grant in the amount of \$154,365,135 from the fund to be received in two tranches, with the first received on May 12, 2021 in the amount of \$77,172,567.50, and the second half of equal value is expected to be received on or about May 12, 2022; and

WHEREAS, on July 27th, 2021 the City Council appropriated \$15,000,000 of ARPA grant funds; and

WHEREAS, the City Council desires to appropriate the ARPA grant funds in accordance with the requirements stipulated in the U.S. Department of Treasury's Final Rule ("Final Rule").

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

THAT, as the recipient of the American Rescue Plan Act ("ARPA") grant funds in the amount of \$154,365,135, the City Council approves the appropriation of \$7,821,018 of the grant funds from the Coronavirus State and Local Fiscal Recovery Funds in accordance with the requirements stipulated by the American Rescue Plan Act and federal guidelines in the Final Rule to cover expenses incurred to respond to the COVID-19 public health crisis.

THAT, the above appropriation was obligated during the period starting March 3, 2021, and ending December 31, 2021.

THAT, the instant and previous appropriations are made in compliance with the Final Rule.

THAT, future appropriations of the remaining CSLFRF funds shall be appropriated in a manner aligning to the needs and requirements of the City and in compliance with the Final Rule guidance.

THAT, the City Manager, or designee, be authorized to effectuate any budget transfers and execute any contracts and/or related documents necessary to ensure that the American Rescue Plan Act ("ARPA") grant funds are properly expended to respond to the COVID-19 public health emergency.

4.	RESOLUTION

WHEREAS, the City Council is expecting to call a Special Election in November of 2022 in order to make certain amendments to the City Charter; and

WHEREAS, the City Council desires the assistance of members of the public to review and make recommendations on potential charter amendments for the special election.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

- 1. That there is hereby created a 2022 Ad Hoc Charter Advisory Committee (the "Committee") composed of nine members who are representative of the community and residents of El Paso. The Members of City Council shall each recommend one Committee member, to be appointed in the manner provided by the City Charter Section 3.7(B).
- 2. The Committee shall begin its work as soon as a quorum of members are appointed.

- The Committee shall appoint a Chair and a Vice-Chair by a simple majority vote of members present at its first meeting. The Chair shall establish such procedures as are appropriate for the orderly consideration of the business of the committee and shall preside over the meetings.
- 4. The Committee will review proposed charter amendments approved by a majority vote of the City Council to be submitted to the Committee; and shall consider public input regarding potential amendments to the Charter.
- 5. The Committee shall strive to meet at least once every two weeks, but in no instance meet less than once per month.
- 6. The Committee shall be subject to any federal, state or local emergency guidance, proclamation, ordinance and City Policy relating to the meeting of Boards and Commissions.
- 7. The Committee will present its final recommendations to the City Council no later than July 5, 2022. The committee may be required to provide status reports to City Council at regular intervals leading up to its final recommendations report.
- 8. All meetings of the Committee shall be open to the public in the manner required by any applicable City Council Ordinance or rule, and notice of all meetings shall be posted at least seventy-two hours prior to the meeting.
- 9. The City Manager shall provide staffing and administrative assistance to the Committee for the purpose of scheduling and giving notice of the meetings, the preparation of minutes of each meeting, and the provision of other reasonable support services.
- 10. The members of the Committee shall not be subject to the financial disclosure requirements of Section 2.92.050 of the City Code, but shall otherwise be subject to all other applicable provisions of City Code Chapter 2.92 (Ethics Ordinance), including completing the training required by section 2.92.090 and any other required training.
- 11. The Ad Hoc Charter Advisory Committee shall automatically dissolve upon the completion of its business.
