Project Location- El Paso International Airport



Project Details

- The Security Identification Display Area (SIDA) is a controlled portion of the airport where personnel and contractors must continuously display proper identification, in compliance with Transportation Security Administration (TSA) regulations.
- SIDA ramps are a critical part of this secure zone, providing aircraft parking and facilitating loading and unloading operations.
- This project will expand the current SIDA ramp to support uninterrupted ramp operations, and ensure ongoing compliance with TSA security requirements.

Scope of Work

- New construction of an additional section of SIDA Ramp pavement and associated drainage improvements.
- The new asphalt surface will be completed to approximately existing grades, with verification of Federal Aviation Administration surface gradient criteria and possible minor grade corrections.
- The services requested are for the design of this project.

Consultant Selection

Selection process was qualification based through the City's A/E selection process.

Reasons for selecting consultant:

- Demonstrated understanding of Federal Aviation Administration Advisory Circulars.
- Demonstrated project manager and team experience.
- Demonstrated project understanding and approach.
