El Paso, Texas- Code of Ordinances

Section 12.85.070A3- Enforcement

An additional fine if not paid within the specified time. An additional fine of ten dollars will be assessed every thirty days until paid; provided, however, that said "additional fine" will not exceed sixty dollars. Should the city declare an amnesty period for outstanding citations, the city council, by resolution, may reduce the amount of the fine for violators who pay voluntarily within the amnesty period.

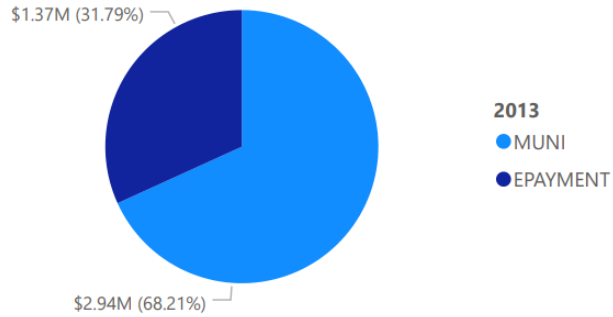

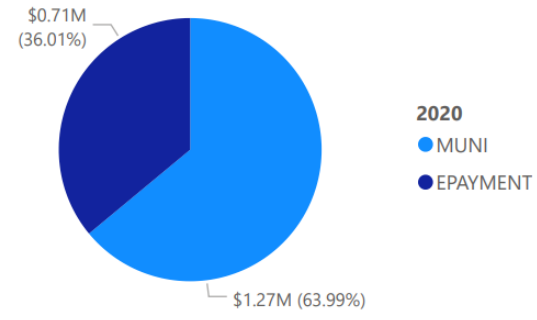
