Solicitation was advertised on May 27, 2025 and June 3, 2025. The solicitation was posted on City website on May 27, 2025. There was a total of ten (10) viewers online; one (1) bid was received from a local supplier.

#### **CONTRACT VARIANCE:**

The difference based in comparison to the previous contract is as follows: An increase of \$40,500.00 for the original award term, which represents a 90% increase due to an increase in prices for parts and an increase in the contract time from 6 months to 3 years.
