BACKGROUND / DISCUSSION:

From the stakeholder discussions, the current Mayor and City Council of El Paso appointed acting members to the Youth Advisory Board to revive the board and continue the engagement and inclusion of youth as part of the process for decisions and functions of the City of El Paso.

From April 28 Council Work Session: Item 1. Presentation, discussion, and action to approve a Resolution of the City Council of the City of El Paso, Texas, pursuing designation as a United Nations Children's Fund (UNICEF) Child Friendly City and authorizing city staff to initiate the formal application process in partnership with UNICEF. Item was approved unanimously.

Steps in the CFCI Candidate Cycle

The following are key steps each city or community will follow in seeking recognition as a UNICEF Child Friendly City in the U.S.

6. Achieving Recognition as a Child Friendly City


Upon successful completion of an independent implementation evaluation, receive and celebrate recognition as an official UNICEF Child Friendly City.

5. Implementing and Evaluating the Local Action Plan (1-2+ years)

Work with young people and local leaders to turn the plan into action, monitoring progress against commitments in preparation for an independent implementation evaluation.

1. Joining CFCI (2-3+ months)

Complete a Readiness Assessment and sign an MOU to officially become a CFCI partner community.



2. Engaging Community Stakeholders (2-3+ months)

Build your bench to improve child rights in the city. Engage stakeholders across sectors, including youth.

3. Conducting a Situation Analysis (3-4+ months)

Leverage qualitative and quantitative insights to understand the state of child rights and well-being in the community.

4. Building the Local Action Plan (6-9+ months)

Identify local priorities and build a plan to improve child rights and well-being in the community.

RECOGNITION AND RENEWAL

1. Joining CFCI: Establish the city's or community's existing resources and preparedness to complete the CFCI process. To complete this step, engage in an exploratory conversation with UNICEF USA. Upon invitation, complete and review a Readiness Assessment in consultation with UNICEF USA. Based upon readiness, organizational capacity and alignment with UNICEF USA's strategic priorities, sign a Memorandum of Understanding (MOU) and formalize participation with UNICEF USA focal point.


2.Engaging Community Stakeholders: Identify a CFCI coordinator, establish a CFCI Task Force (internal city implementing team) and CFCI leadership team (executive committee of dedicated citywide leaders) and determine how the city will ensure meaningful youth participation throughout the CFCI process. To complete this step, submit and review the Stakeholder Engagement Summary Form with UNICEF USA.

3. Conducting a Situation Analysis: Gather quantitative and qualitative insights reflecting the state of children in the city by conducting community conversations and collecting city data across the five CFCI goal areas. To complete this step, finalize a Situation Analysis publication and distribution plan and submit and review a <u>Situation Analysis</u> <u>Summary Form</u> with UNICEF USA.

4. Building the Local Action Plan: Based on the results of the Situation Analysis, convene city leaders, children and youth to identify, analyze and identify practical solutions for at least one or more priority issues, as well as any strategies to strengthen child-centered governance. Based on this input, draft a logic model and a one- to two-year+ Local Action Plan (the former for pilot cities, the latter for post-pilot cities), along with metrics and data sources to monitor progress. To complete this step, finalize a Local Action Plan publication and distribution plan and submit and review a Local Action Plan Summary Form with UNICEF USA.

5. Implementing and Evaluating the Local Action Plan: Implement the Local Action Plan with city leaders, community partners and children and youth. Participate in regular check-ins with UNICEF USA to review the status of progress against commitments in the plan. Schedule a midterm review with UNICEF USA and an independent evaluator. Upon completion of the plan, undergo an Implementation Evaluation with UNICEF USA's designated external evaluator.

6. Achieving Recognition: If UNICEF USA affirms that requirements are met, the city will receive official recognition as a UNICEF Child Friendly City. **To complete this step**, receive and celebrate recognition and submit and review a **Post-Recognition Reflection Form** with UNICEF USA.



Duration: During the initial pilot, UNICEF USA's
Candidate Phase took place over an estimated 24
months: 12 months to develop a network of stakeholders in the city, analyze the state of child rights and develop a
Local Action Plan, followed by at least 12 months to implement
and evaluate the city's Local Action Plan, receiving official
recognition valid for an initial 24 months. All cities that joined
CFCI after the pilot ended (after July 1, 2024) or that renewed for
a second cycle will engage in a 36-month Candidate phase and
develop at least a 24-month Local Action Plan.

Renewing CFCI Partnership: Upon recognition as a UNICEF Child Friendly City, the city has the option to renew its partnership with UNICEF USA by committing to undergo a renewal cycle, helping to ensure sustainability of child-centered governance structures and deepening its commitment to child rights and positive impacts for children and young people. To undergo a renewal cycle, complete and review a condensed Renewal Readiness Assessment with UNICEF USA to determine that the city is ready for renewal and sign an MOU or addendum.

Summary Forms: At the conclusion of each step, cities will complete a summary form to provide evidence of and reflections on the completion of requirements of the step. The appendix includes links to the required summary forms for each step of the CFCI process.

Every child and young person is valued, respected and treated fairly.



Every child and young person has their voice heard and considered.



Every child and young person has access to basic needs like food, education and health


care.

Every child and young person is able to enjoy family time, play and relaxation.
