Trees adopted by residents will consent to an agreement to maintain and water their drought tolerant trees aided by a native tree plant guide provided by Texas A&M AgriLife Extension. The Program will continue with the support of the *Love your Block* program and other climate initiatives to ensure its future sustainability. The Program is not limited to any area in the city and is open to additional parties wishing to participate, in alignment with the program's mission. Representative Isabel Salcido wishes to dedicate the use of discretionary funds in the amount of \$1,500 to provide incentives to volunteers who participate in tree planting events. Three incentives in the amount of \$500 will be provided to volunteers through random selection for participation.

Further, that the City Manager is authorized to effectuate any budget transfers necessary to ensure that the funds are properly expended for such purpose and is authorized to execute any related agreements, amendments to such agreements, and documents necessary to carry out the purpose of this Resolution.
