Solicitation was advertised on August 25, 2020 and September 1, 2020. The solicitation was posted on City website on August 25, 2020. The email (Purmail) notification was sent out on August 27, 2020. There were a total nineteen (19) viewers online; Two (2) bids were received, zero (0) from local suppliers. An Inadequate Competition Survey was conducted.

CONTRACT VARIANCE PREVIOUS CONTRACT:

The difference in cost, based on the comparison from previous contract is as follows: An increase of \$6,071.25 for the initial term, which represents a 7.16% increase, due to price increases.

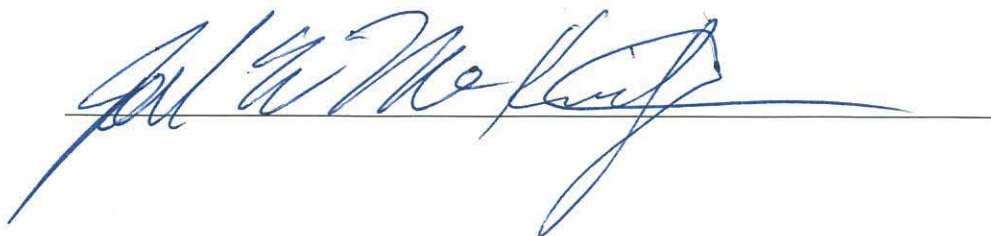
