The scope of work includes the following tasks: 1) Project Management, 2) Public Outreach and Engagement, 3) Reconnaissance and Visioning, 4) Comprehensive Update to Plan El Paso, 5) Realign Project Goals and Policies with an Equity Lens, 6) Project List and Recommendations, and 7) Final Documents and Implementation.
