SUBGOAL: 5.2: Leverage and expand the use of current and new technology to reduce inefficiencies and improve communications

SUBJECT:

That the Mayor be authorized to sign an Interlocal Governmental Agreement between the City of El Paso and the County of El Paso for Law Enforcement Information Sharing for the On-Call Records (WebRMS) Management System. The City will fund the Interlocal Governmental Agreement Law Enforcement Information Sharing for the On-Call Records (WebRMS) Management System at 50% and the County of El Paso will fund in the amount of 50%. This agreement further serves to create and provide the framework for the operation of WebRMS, which serves as a regional law enforcement information sharing resource between the Sheriff's Office, the El Paso Police Department and other area law enforcement agencies that may choose to participate.

BACKGROUND / DISCUSSION:

The new agreement supersedes the agreement entered on February 13, 2003. The Interlocal Agreement between the County of El Paso and the City of El Paso for Law Enforcement Information Sharing Mutual Support Services for the Combined Records Information Management Enterprise System (CRIME) was entered into on February 13, 2003. This interlocal agreement provides for the continued mutual support services of a regional law enforcement information system that provides the means for participating agencies to share law enforcement information. This information sharing is possible through a common system known as the On-Call Records (WebRMS) Management System. Both parties shall be participating agencies. This agreement includes all items necessary to define the terms and arrangements between the parties.

Under the proposed Interlocal Agreement shared costs will be funded by a 50/50 split between the City of El Paso and El Paso County, Texas.

PRIOR COUNCIL ACTION:

February 13, 2003, Item 4.R. Under this interlocal shared costs, including maintenance and support costs for Web RMS, were paid 80% by the City and 20% by the County.

AMOUNT AND SOURCE OF FUNDING:

Fifty-Percent of Web RMS support paid to El Paso County is currently estimated at \$165,492.69 per year.
