Mr. Normand-Ribas stated that The Bob Bullock Texas State History Museum in Austin has requested an artifact loan for their upcoming exhibit titled, *Texas Roots*. The Bullock Museum's curatorial team has requested to borrow this piece for a one-year period, from July 2024 to July 2025.

- 9. Discussion and Action on El Paso Museum of Art Accessions.** Edward Hayes, Director, addressed the Board to introduce the agenda item. Claudia Preza, Assistant Curator, addressed the Board; she began by presenting photos of three proposed donations. The first proposed donation piece, *If you say something see something (Cornucopia N.1)* by artist Alejandro Almanza Pereda. Ms. Preza added that, if approved, it would enhance the Museum's sculpture collection and Mexican contemporary artwork. The second proposed donation presented was *The Jim Drawings, #25* by artist Gael Stack, and the third was *Woman with Cell Phone*, by artist James Drake. Ms. Preza provided detailed information for each piece. She then presented four proposed purchases with funds provided by the Estate of Lineaus Hooper Lorette, which, if approved, will be acquisitions for the 2024 Border Biennial. The first piece is by artist Haydee Alonso, *"Bad" hyphens separate; "good" hyphens attach*, a sterling silver and brass earring, accompanied by a photograph by Miguel Eduardo Vargas. The second consideration is a digital photograph by artist Pico del Hierro-Villa, *Las Virgencitas Enamoradas, part of the "Breaking the Borders of La Virgen de Guadalupe" Series*. The third purchase for consideration is a textile work by artist Andres

Payan Estrada, *Queer Topographies (Briar Patch)*, and the fourth is an oil on canvas by artist George Strasburger, *Two Men on a Trail*.

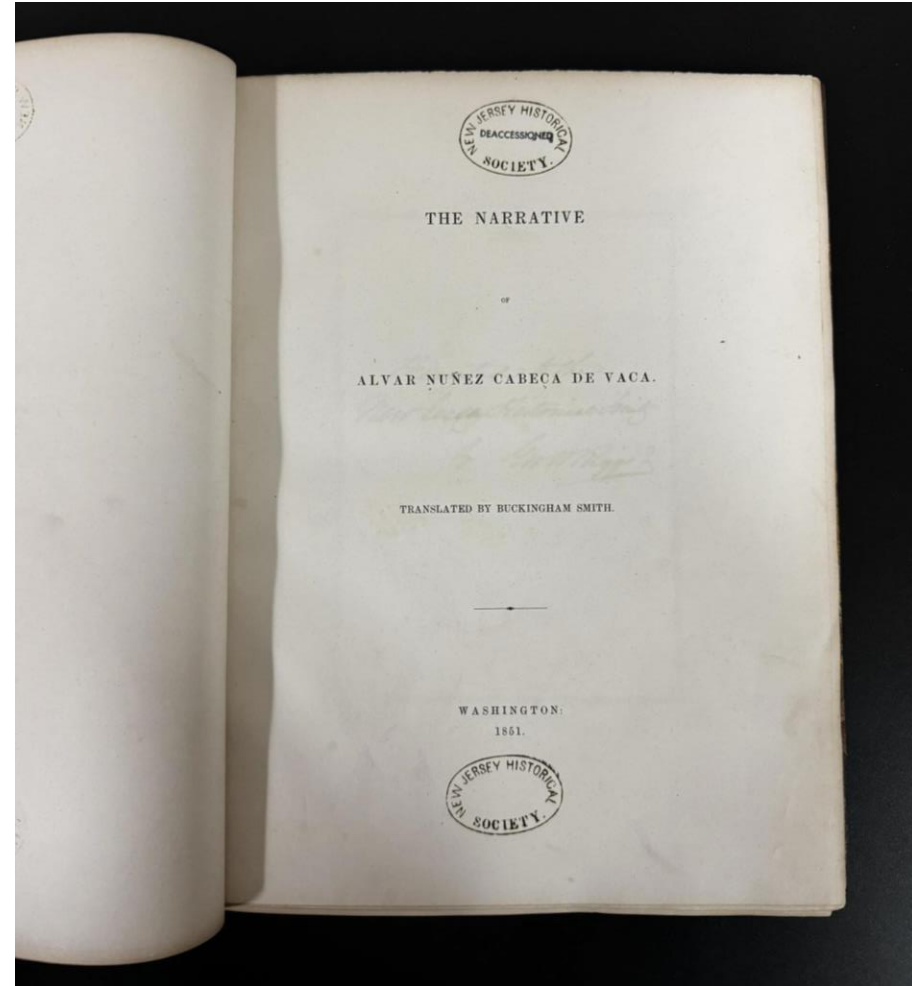
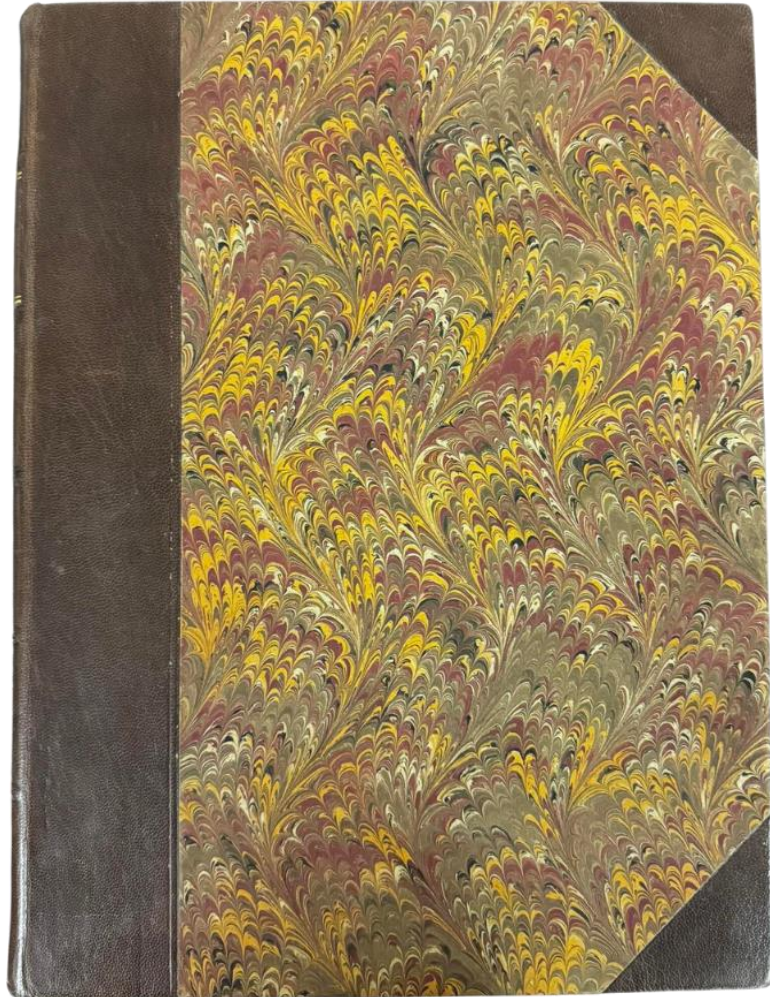
