**SUBJECT:** Resolution that the City Manager be authorized to sign an amendment to Funding Agreement with the El Paso Children's Museum Development Corporation by and between the City of El Paso ("City") and the El Paso Children's Museum Development Corporation ("EPC") for the purpose of changing the frequency of the distribution of the City's Funding Stipend Commitment from guarterly installments to monthly installments.

## **BACKGROUND / DISCUSSION:**

Per original agreement, the City pays 33% of La Nube's operating expenses (capped at \$2.5 million) paid as reimbursements on a quarterly basis. With La Nube having begun normal operations, both MCAD and La Nube are in favor of amending disbursement schedule from quarterly to monthly. This will allow:

- 1. Greater cash flow for La Nube
- 2. MCAD staff to catch any issues easier with receipts, backup, reporting in real time on a monthly basis

### PRIOR COUNCIL ACTION:

Original funding agreement was approved by Council in April of 2016.

## AMOUNT AND SOURCE OF FUNDING:

Stipend is budgeted annually in the adopted budget for MCAD.

# AMENDMENT TO FUNDING AGREEMENT WITH THE EL PASO CHILDREN'S MUSEUM DEVELOPMENT CORPORATION

This Amendment is made and entered into by and between The City of El Paso, Texas, a homerule city and political subdivision of the State of Texas ("City") AND The El Paso Children's Museum, a non-profit corporation of the State of Texas ("EPC").

**WHEREAS**, The parties entered into the El Paso Children's Museum Memorandum of Understanding on August 23<sup>rd</sup> of 2016 with the intent to provide a first-class, state of the art Children's Museum in the City ("**Museum**"), and

**WHEREAS**, The parties entered into a revised Memorandum of Understanding on March 6<sup>th</sup> of 2018 ("**MOU**"), and

WHEREAS, The parties entered into a funding agreement approved by resolution on July 23<sup>rd</sup> of 2018 ("Funding Agreement"), and

WHEREAS, The parties desire to amend certain sections of the Funding Agreement to change the frequency of the distribution of the City's Funding Commitment funds from quarterly installments to monthly installments

**NOW, THEREFORE**, the parties enter into the following changes to the Funding Agreement.

**1. CITY FUNDING- STIPEND COMMITMENT.** It is mutually understood that 1.3 (B)(i) of the Funding Agreement will be amended to read as follows:

"The Stipend shall be paid beginning on the Stipend Commencement in a prorated amount, and thereafter in monthly installments on the first day of each month. At the end of the last month of each year of the Lease (as may be extended), Museum Operator shall provide the City with a financial statement providing budget versus actual variances for the year, The City shall "true up" any amounts owed or overpaid to Museum Operator in its next monthly payment."

**2. EXPLICIT CHANGES.** Anything not explicitly amended above will remain as written in the Funding Agreement.
