The award of solicitation 2023-0180 OEM Alternators, Starters and Related Parts to The McAdams Group, LLC dba Texas Alternator Service, for a three (3) year term for an initial estimated amount of \$107,178.00. The award also includes a two (2) year option for an estimated amount of \$71,452.00. The total amount of the contract is, including the initial term plus the option for a total of five (5) years, for an estimated amount of \$178,630.00.

BACKGROUND / DISCUSSION:

This contract will provide Replacement Alternators, Starters and Related Parts to the Fire Department.

SELECTION SUMMARY:

Solicitation was advertised on December 13, 2022 and December 20, 2022. The solicitation was posted on City website on December 13, 2022. There were a total of fourteen (14) viewers online; three (3) bids were received; none being local.

CONTRACT VARIANCE:

The difference based in comparison to the previous contract is as follows: A decrease of \$1,367.40 for the initial term, which represents a 1.26% decrease due to improved pricing.


