An Ordinance amending Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.230 (Schedule XX—Parking Benefit Districts), to amend references and language regarding the Uptown Parking Benefit District Advisory Committee in its entirety.

BACKGROUND / DISCUSSION:

During the May 12, 2025 City Council meeting, Council directed boards and commissions be standardized, to provide consistent governance and operational procedures across all city boards and commissions to ensure efficient and effective public administration. Council also provided the directive to expand the boundaries of the Uptown Parking Benefit District which allows for the neighborhoods and businesses directly affected to have representation and for funds to address needs in the residential districts.

ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.230 (SCHEDULE XX—PARKING BENEFIT DISTRICTS), TO AMEND REFERENCES AND LANGUAGE REGARDING THE UPTOWN PARKING BENEFIT DISTRICT ADVISORY COMMITTEE IN ITS ENTIRETY.

WHEREAS, the El Paso City Council establishes City Boards and Commissions to inform City Council under statutory authorization or on particular issues or subjects of interest to the Council; and

WHEREAS, the City of El Paso recognizes the importance of consistent governance and operational procedures across all city boards and commissions to ensure efficient and effective public administration; and

WHEREAS, on May 12, 2025, City Council directed boards and commissions be standardized; and

WHEREAS, by Ordinance No. 018762, the El Paso City Council created the Uptown Parking Benefit District and boundary for the Uptown Parking Benefit District; and

WHEREAS, the El Paso City Council wishes to amend the El Paso Municipal Code enacting the Committee's designated district boundary.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

SECTION 1. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.230 (Schedule XX—Parking benefit districts) be amended to read:

Uptown parking benefit district

Beginning at the southwest corner of Oregon Street and Rim Road,
Thence north along the western boundary of Oregon Street to its intersection with the northern boundary of Glory Road,

Thence east along the northern boundary of Glory Road to its intersection with the eastern boundary of North Mesa Street,

Thence north along the eastern boundary of North Mesa Street to its intersection with the southern boundary of Gregory Avenue,

Thence east along the southern boundary of Gregory Avenue to its intersection with the western boundary of Stanton Street,

Thence south along the western boundary of Stanton Street to its intersection with the northern boundary of Coffin Avenue,

Thence east along the northern boundary of Coffin Avenue to its intersection with the eastern boundary of Florence Street.

Thence south along the eastern boundary of Florence Street to its intersection with the southern boundary of Robinson Avenue,

Thence west along the southern boundary of Robinson Avenue to its intersection with the eastern boundary of Campbell Street,

Thence south along the eastern boundary of Campbell Street to its intersection with the northern boundary of New York Avenue,

Thence east along the northern boundary of New York Avenue to its intersection with the eastern boundary of North Saint Vrain St,

Thence east along the southern boundary of Arroyo Park to its intersection with the eastern boundary of Rim Road,

Thence west along the southern boundary of Rim Road to the point of beginning.

SECTION 2. Except as expressly herein amended, Title 12 (Vehicles and Traffic), chapter 12.88 (Schedules), section 12.88.230 (Schedule XX—Parking benefit districts) of the El Paso City Code shall remain in full force and effect.

SECTION 3. Except as expressly herein amended, all other provisions of the El Paso City Code will remain in full force and effect. Any provision of this ordinance deemed illegal will be severed and the remainder will remain in effect. The requirements of this ordinance will take effect 90 days from its adoption and publication in accordance with and as provided by law and the City Charter.




