A Resolution to convene the Districting Commission as required by Article II, Section 2.4(B) of the City Charter.

BACKGROUND / DISCUSSION:

Realignment of representative district boundaries of the City of El Paso is required after the completion of the U.S. Decennial Census. The 2020 Census counts were completed on September 1, 2020.

PRIOR COUNCIL ACTION:

Council previously convened the Districting Commission on May 10, 2011. The Districting Commission disbanded on July 23, 2012 upon approval of a final District Plan by City Council.

RESOLUTION

WHEREAS, under Public Law 94-171, after the completion of the 2020 U.S. Census, realignment of representative district boundaries of the City of El Paso is required when the difference in population between the largest and smallest district exceeds 10%; and

WHEREAS, Article II, Section 2.4(B) of the City Charter ("Charter") states that a Districting Commission (hereinafter referred to as the "Commission") shall be convened on or before September 1st, following publication of the results of each decennial census; and

WHEREAS, the Charter provides that the Commission shall consist of one qualified voterappointed by each of the City representatives from their respective Districts, and one qualified voter from the City at large appointed by the Mayor; and

WHEREAS, all changes to boundaries of the representative district must comply with the constitutional principles and laws governing voting rights of the United States and Texas.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF EL PASO:

- 1. That a Districting Commission shall be convened;
- 2. That the Mayor and each of the Representatives shall appoint one member to the Commission on or before September 1, 2021, as provided by the Charter;
- 3. That the Commission shall perform the duties identified in the Charter, shall comply with all requirements of the laws governing voting rights and redistricting criteria within the allotted time frame, shall solicit input from the general public, and shall prepare a consensus recommendation for approval by City Council; and
- 4. That all members appointed to the Commission shall serve, without compensation, until City Council adoption of a Redistricting Plan.

Appointment Requirements

- Each Representative shall nominate one qualified voter from their district
- Mayor shall nominate one qualified voter from the City at large
- Appointees shall not serve the City in any other capacity, whether appointive or elective, nor shall they hold any other elective public office

Federal and State Guidelines for District Plans

- 1. **Identifiable** geographic boundaries
- 2. Containing **communities of interest** in single districts; avoid splitting neighborhoods
- 3. Containing whole voting precincts
- 4. Boundaries should be based on **existing districts**
- 5. Approximately **equal size**: Population of largest district ≤ 10 percent more than population of smallest district.
- 6. Compact and contiguous territory
- 7. Preserving incumbent-constituent relations
- 8. **No retrogression** in ability of minorities to participate in electoral process
- 9. No fragmentation of minority communities or packing of minority voters
