

FIRST AMENDMENT TO  
INDEPENDENT CONTRACTOR AGREEMENT  
JOHN HARGROVE CONSULTING

This 1st Amendment to that certain Independent Contractor Agreement for Wireless Telecommunication Consulting Services is made this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between the City of El Paso, a home rule municipal corporation organized and existing under the laws of the State of Texas (the “City”, and John Hargrove Consulting, (the “Contractor”).

**WHEREAS**, on April 14, 2020, the CITY and CONTRACTOR entered into a(n) Independent Contractor Agreement for Wireless Telecommunication Consulting Services (“Agreement”);

**WHEREAS**, the Agreement may be amended under the provisions of Section 4 of the Agreement; and

**WHEREAS**, the parties desire to extend the duration of the agreement to allow CONTRACTOR to continue to provide the contracted services.

**NOW THEREFORE**, in consideration of the mutual promises set forth in this 1<sup>st</sup> Amendment and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Section 2 of the Agreement is amended to add the following:
  - 2.1 The services of Contractor are extended beyond the initial term, including options, for an additional 4 years, to terminate April 13, 2027.
2. All terms and conditions of the Agreement and all subsequent Amendments thereto, except as herein revised, shall remain in full force and effect.






