AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.44 (STOPPING, STANDING AND PARKING GENERALLY), SECTION 12.44.180 (REGULATIONS PERTAINING TO CERTAIN SPECIAL SITUATIONS), SUBSECTION B (THE REGULATIONS APPLICABLE TO EACH SUCH ZONE ARE AS FOLLOWS:), TO DELETE PARAGRAPH 31 (RESERVED FOR LIBRARY VEHICLES ONLY), ITEM B. TWO SPACES ON THE NORTH SIDE OF FRANKLIN AVENUE BETWEEN OREGON STREET AND EL PASO STREET, AND TO ADD PARAGRAPH 34 (RESERVED FOR LIBRARY AND MEXICAN AMERICAN CULTURAL CENTER (MACC) VEHICLES ONLY), ITEM A. TWO SPACES ON THE NORTH SIDE OF FRANKLIN AVENUE BETWEEN OREGON STREET AND EL PASO STREET; THE PENALTY AS PROVIDED FOR IN SECTION 12.84.010 OF THE EL PASO CITY CODE.

WHEREAS, Streets and Maintenance received a request from the directors of the Library and Mexican American Cultural Center (MACC) to designate parking on the north side of Franklin Avenue between Oregon Street and El Paso Street for both departments; and

WHEREAS, new signage will have to be fabricated and installed designating the two parking spaces for Library and MACC vehicles.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

SECTION 1. That Title 12 (Vehicles and Traffic), Chapter 12.44 (Stopping, Standing and Parking Generally), 12.44.180 (Regulations Pertaining to Certain Special Situations), Subsection B, is hereby amended to delete Paragraph 31 (Reserved for Library Vehicles Only), item b, and to add Paragraph 34 (Reserved for Library and Mexican American Cultural Center (MACC) Vehicles Only), item a:

B. The regulations applicable to each such zone are as follows:

1.—30.

31. Reserved for Library Vehicles Only.

a. Three spaces within the curb setback on the west side of Oregon Street, between Franklin Avenue and Missouri Avenue; and

32.—33.

34. Reserved for Library and Mexican American Cultural Center (MACC) Vehicles Only.

a. Two spaces on the north side of Franklin Avenue between Oregon Street and El Paso Street.

SECTION 2. Except as herein amended, Title 12 of the El Paso City Code shall remain in full force and effect.
