

Scope of Work

Task 1: Infrastructure Assessments

Engineering consultants will evaluate existing roads, rails, energy distribution, broadband capacity, and airport/military support services. Recommendations will address needs for upgrades, resilience measures, and future-proofing critical systems.

Task 2: Land Use Analysis and GIS Mapping

Planning consultants will work with City staff to map existing land uses, identify potential conflicts, and explore new zoning solutions. This geographic analysis will guide recommendations for compatible growth and highlight critical infrastructure corridors.





Scope of Work

Task 3: Stakeholder Engagement

The JLUS process will commence with structured meetings, workshops, and listening sessions involving the City of El Paso, Fort Bliss leadership, Airport operations, the State of Texas, private landowners, local businesses, utility providers, law enforcement agencies, and community organizations.

Task 4: Draft and Final SHIELD Report

The final deliverable will be a comprehensive plan outlining land use guidelines, zoning recommendations, proposed infrastructure investments, economic strategies, security considerations, and collaborative training arrangements.
