WHEREAS, at this time, Applicant has chosen not to proceed with an agreement for payment to the City; and

WHEREAS, due to the absence of a payment agreement with Applicant, City wishes to remove from the Project’s Scope of Work the installation of school flashers, pavement striping, signage, landscaping, and concrete improvements at the intersection of Frontera Road and Roxbury Drive and seeks approval of a deductive change order in the amount of \$436,798.22 from the original Contract Amount.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

1. THAT the City Council approves the attached deductive change order in the amount of \$436,798.22 to Contract No. 2024-0472 Traffic Signal Improvements.
