Recognize Lieutenant Marvin Ryals for being the first El Paso County Law Enforcement Officer (LEO) to be elected as President of Combined Law Enforcement Associations of Texas (CLEAT), the largest police officers' union in Texas, representing law enforcement rights and interests statewide.

## BACKGROUND / DISCUSSION:

Lieutenant Marvin Ryals started his career with the El Paso County Sheriff's Office in 1978. He worked his way through the ranks starting as a Detention Officer and became a Deputy Sheriff in 1979. Lt Ryals is one of the original founding members of the El Paso County Sheriffs Officer's Association which started in 1978. Lt Ryals spent much of his off-duty time knocking on doors and gathering support from the community to get Deputies the right to collective bargaining. In 1991, Lt Ryals fought to get Detention Officers included in being covered under collective bargaining, setting the precedence for Detention Officers across the State of Texas. With the hard work of Lt Ryals and others, El Paso County was the first County in Texas to get collective bargaining rights. Lt Ryals has served on the El Paso County Sheriffs Officer's Association Board 3 times as President and has served several other terms as Executive or Director positions, to include being the current Board Secretary. Lt Ryals joined CLEAT in 1979 and has served on the State Board for 18 years in the capacity of Director, Vice President and now is only the 4th CLEAT President to serve in the over 40 year history of CLEAT, and is the first to represent an El Paso law enforcement organization.
