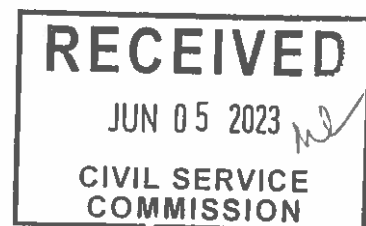
As a result of the request by Ramiro Vega that he wants to dismiss his appeals, the following order is entered.
