B) RESOLUTION

WHEREAS, on March 13, 2020 the President of the United States declared a national emergency, the Governor of the State of Texas declared a state of disaster, and the Mayor of the City of El Paso ("City") declared a local state of disaster in relation to COVID-19; and

WHEREAS, on March 17, 2020 City Council Issued an Emergency Ordinance Instituting Emergency Measures Due to A Public Health Emergency ("Emergency Ordinance"); and

WHEREAS, on March 27, 2020, the federal government enacted the Coronavirus Aid, Relief and Economic Security Act ("CARES Act"), which established the Coronavirus Relief Fund ("Fund") and appropriated \$150 billion to the Fund to be used to address the economic fallout caused by the COVID-19 pandemic; and

WHEREAS, the City is a recipient of the CARES Act grant in the amount of \$118,956,278.90 from the Fund; and

WHEREAS, on May 11, 2020 City Council approved appropriations for the CARES Act funds received by the City on eligible expenses from March 1, 2020 through December 30, 2020; and

WHEREAS, the City has on-going COVID-19 related expenditures that are expected to continue into FY 2021; and

WHEREAS, on March 3, 2020 City Council established a Stabilization Fund which allows for the use of funds to provide funding for specific circumstances or state of emergencies as determined by City Council; and

WHEREAS, the City wishes to allocate funds from the Stabilization Fund toward the ongoing expenditures associated with the COVID-19 emergency.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

THAT City Council approves the appropriation of funds from the Stabilization Fund to cover public health and safety costs associated with the COVID-19 emergency that:

- Will allow for the ongoing public and health response and operations expenses associated with the COVID-19 Pandemic, in an amount not to exceed \$16,816,869 during FY2021;
- 2. These expenses are necessary expenditures for public health and safety solely attributable and incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID–19) through August 31, 2021.

THAT, the City Manager, or designee, be authorized to effectuate any budget transfers and execute any contracts and/or related documents necessary to ensure that the funds are properly expended for such purposes.
