RESOLUTION

WHEREAS, the City Council of the City of El Paso has appropriated discretionary funds for use by City Council Members to support projects and activities that serve a valid municipal purpose and benefit the residents of the City of El Paso; and

WHEREAS, Mayor Pro Tem Alejandra Chavez has requested the use of District 1 Discretionary Funds in the amount of Ten Thousand Dollars (\$10,000.00) to support the Borderland Mountain Bike Association's Lost Dog Trailhead Renovation Fund; and

WHEREAS, the Lost Dog Trailhead Renovation Fund supports improvements to public recreational amenities that promote outdoor recreation, environmental stewardship, public health, tourism, and community engagement for the benefit of the residents and visitors of the City of El Paso; and

WHEREAS, the City Council finds that the expenditure of District 1 Discretionary Funds for this purpose serves a valid municipal purpose by enhancing the quality of life through recreational, cultural, and educational opportunities and improving public recreational infrastructure within the City of El Paso.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO THAT:

1. The use of District 1 Discretionary Funds in the amount of Ten Thousand Dollars (\$10,000.00) is hereby approved for the Borderland Mountain Bike Association's Lost Dog Trailhead Renovation Fund.
2. The City Council finds that this expenditure serves a municipal purpose by enhancing El Paso's quality of life through the improvement of recreational facilities and promoting public access to safe and accessible outdoor recreational opportunities.
3. The City Manager, or designee, be authorized to effectuate any budget transfers up until November 30, 2026, and execute any contracts and/or related documents necessary to ensure that the funds are properly expended for the municipal purpose, and at that time, return any remaining unused funds for this expenditure to the District 1 Discretionary Fund Account without further Council action.
