- Founded more than 40 years ago in Chihuahua
- More than 14,000 associates internationally
- Purchased \$279M in products from the US in 2021
- Exported \$30M to the US in 2021
- 3 companies currently in El Paso accounted for \$89M in sales in 2021




Renovate old (Kasco Structures steel fabricating facility) and construct a new 61,000 SF cold storage facility, warehouse and administrative building which will result in the retention of 155 full-time jobs and the creation of 120 FTEs



Site Location & Design: 1600 E. Fourth Ave.





- 2-story corporate office building
- Cold storage and warehouse
- May include cafeteria and market open to the public
- Facility will become U.S. Headquarters
- Expect 95% of power to be supplied by solar
- Future opportunities may include the expansion of grocery stores

Site Location & Design: 1600 E. Fourth Ave.





- Retain 155 FTEs and add
 120 new full-time positions
- Positions include full benefits package
- Median wage \$17.55 per hour


Compared to median \$8.65 per hour in adjacent census tracts where fewer than 30 percent of residents have insurance


- Project operations directly support 120 jobs and average annual salaries of nearly \$18.7 million.
- Through spending, an additional 101 jobs are supported.
- In total, 221 jobs are supported by the project, representing \$35.0 million in average annual salaries.

Community Tax Benefit

10-Year Total Tax Benefit after Incentives



Tax Benefit after Incentives Over 10-Year Term = \$2,931,486



*Estimated tax benefit includes tax revenue from the expansion less incentive value; costs associated with government services are needed to support the expansion are not included.



Recommendation

- Incentive proposal aligns with the City's 380 Incentive Policy given the project location and type
- Project aligns with other policy objectives, including use of renewables, location of U.S. headquarters, and addresses equity
- Recommendation: Move forward with the approval of a Chapter 380 Agreement.
