### Adoption of 2024 Building and Heavy / Highway Prevailing Wage Rates

- In 2012, the County of El Paso proposed a joint effort to update wage rates for local government use.
- On May 8, 2012, the City authorized an Interlocal Agreement with the County to participate in a survey of prevailing rate per diem wages.

- The City of El Paso currently uses the 2020 Building Wage Rates: approved December 7, 2021 and
- The 2016 Heavy/Highway Wage Rates: approved February 28, 2017 for all construction contracts.
- Under Texas Government Code Chapter 2258, the City must determine prevailing per diem wage rates for each worker type within its limits for public works projects every four years.

## **Criteria for 2024 Prevailing Wage Rates**

Building Construction Prevailing Wage Rates:

- Use Davis Bacon Rates, if 3 or more responses received and not less than 2020 rates.
- If no Davis Bacon Rate exists nor in 2020 rates, and fewer than 3 responses received, default to 2024 survey rates
- If no Davis Bacon Rate exists and fewer than 3 responses received, default to 2020 rates

#### Heavy and Highway Construction Prevailing Wage Rates:

- Use Davis Bacon rates, unless 3 or more responses were received.
- If no Davis Bacon Rate exists and fewer than 3 responses received use 2024 survey.
