Whereas, it is important to bring the definitions used by Sun Metro in determining eligibility for reduced fairs in line with the Adult Mental Health Priority Population ("AMHPP") definition used by the State of Texas; and

Whereas, the Texas Administrative Code defines Adult Mental Health Priority Population as adults who have severe and persistent mental illnesses such as schizophrenia, major depression, bipolar disorder, post-traumatic stress disorder, obsessive compulsive disorder, anxiety disorder, attention deficit/hyperactivity disorder, delusional disorder, bulimia nervosa, anorexia nervosa, or other severely disabling mental disorders which require crisis resolution or ongoing and long-term support and treatment.; and

Whereas, the expansion of the reduced fare eligibility to those who are enrolled in a drug rehabilitation therapy would remove transportation impediments to the individual from receiving such treatment; and

Whereas, it is the mission of Sun Metro to provide transportation services as widely and as equitably as possible; and

Whereas, the City of El Paso finds that reduced fares to El Pasoans suffering from mental health conditions, syndromes and offering the same reduced fare to El Pasoans recovering from addiction constitutes an important public benefit to the citizens of El Paso;

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

THAT Sun Metro will expand its eligibility criteria in the Application for Disability Identification Card to include the following language after the "Organic brain syndrome/emotionally disturbed" category:

"Adults who have severe and persistent mental illnesses which require crisis resolution or ongoing and long-term support and treatment such as schizophrenia, major depression, bipolar disorder, post-traumatic stress disorder, obsessive compulsive disorder, anxiety disorder, attention deficit/hyperactivity disorder, delusional disorder, or other severely disabling mental disorders."

THAT Sun Metro will add a new Section to the Application for Disability Identification Card to include eligibility for those who are enrolled in drug rehabilitation therapy, as mandated by court orders based upon the following criteria:

- 1. The individual attending a drug rehabilitation program must be enrolled:
 - a. with a Licensed Chemical Dependency Counselor;
 - b. be current with all appointments; and
 - c. have court orders in file that mandate the applicant to receive treatment.

THAT language shall be added to the Application for Disability Identification Card that approves people applying for reduced fares on the basis of their being diagnosed with such conditions by a medical certification letter as required by the reduced fare application;

THAT licensed professionals from whom Certification letters would be acceptable for purposes of determining eligibility for Reduce Fares will include the following:

- 1. Nurse Practitioners (NPs),
- 2. Clinical Nurse Specialists (CNSs),
- 3. Physician Assistants (PAs),
- 4. Licensed Chemical Dependency Counselors (LCDCs),
 - 5. Medical Doctors [MDs], and
 - 6. Doctors of Osteopathy [DOs]

In addition to any currently authorized licensed professionals on Sun Metro's Reduced Fare application.

THAT the City Manager is authorized to effectuate any budget transfers necessary to ensure that the funds are properly expended for such purpose and is authorized to execute any related agreements, amendments to such agreements, and documents necessary to carry out the purpose of this Resolution.
