









Residential – Single Family









Residential - Multifamily













Average Taxable ValueSingle Family Home (in thousands)








Property Tax Relief # of Exemptions


Property Tax Rate

- After receiving certified property values, recommended FY 2023 tax rate is a total of <u>4.49 cent decrease</u>, or \$19.3 million
 - 0.75 cent decrease originally recommended, plus additional
 - 3.74 cent decrease
