

What is Vision Zero?

Vision Zero is a strategy to eliminate all traffic fatalities and severe injuries, while increasing safe, healthy and equitable mobility for all.

- Collaborative
- Data Driven
- Design + Process Focused







Vision Zero shifts away from the traditional way of thinking—that crashes are inevitable to a new safe system approach that proactively identifies and addresses risks.

Traditional Road Safety Practices vs. Safe System Approach

Whereas traditional road safety strives to modify human behavior and prevent all crashes, the Safe System approach also refocuses transportation system design and operation on anticipating human mistakes and lessening impact forces to reduce crash severity and save lives.

Why Vision Zero?

On average, between 2016 and 2020 there were 2.95 pedestrian deaths per 100,000 people. This is the 18th worst in the United States, and higher than the Texas average (2.32)

Engagement Plan

Key Engagement Activities

- <u>Vision Zero Dashboard</u>: highlight key crash statistics and make crash data easily accessible to the public
- <u>Vision Zero Website</u>: public updates, announcements, and resources will be held on a public City website
- Social Media: organized and intentional public relations and social media campaign
- <u>Neighborhood Meetings</u>: dispersed neighborhood input in each Council District
- <u>Community Input Meetings:</u> large community-wide events to spread information and gather feedback
- <u>Canvassing:</u> Prioritize conversations in high-crash neighborhoods
- <u>Community Events:</u> be present at events like Chalk the Block, Winterfest, etc.
- Awareness & Education: a branded and visible effort to create awareness for Vision Zero







Vision Zero Task Force Purpose

- Broad cross-section of city departments, agencies, organizations, advocates, and the community that have role to play in safety outcomes.
- Help verify behaviors and trends and guide development of proactive approaches that can address crash trends
- Define roles and partnership opportunities for shared responsibility
- Spread information and awareness
- Five Meetings (October, November, January, March, and May)



El Paso Initial Crash Findings


Crashes where somebody was killed or severely injured (KSI) are up in 2021, after a low in 2020.





Crash Findings


There was a significant drop in 2020, but pedestrian crashes appear to be returning to pre-pandemic levels.

8% of pedestrian crashes result in a fatality, and 12% result in a life-altering injury



City Council Resolution

This resolution is the first step in the VZ process

- Commitment towards the goal of eliminating deaths and serious injuries
- Renew the shared commitment towards making streets safer in El Paso
- Emphasizes equity
- Prioritizes vulnerable road users
- Establishes a Vision Zero Task Force

"WHEREAS, equity is an integral component of Vision Zero with strategies such as prioritizing safety improvements in historically underserved areas and conducting robust engagement programs to reach the most vulnerable on the roadways; and"

"WHEREAS, Vision Zero aligns with the City's Comprehensive Plan, Strategic Plan, Bike Plan, and Complete Streets Policy by prioritizing our most vulnerable roadway users and encouraging balance among all users of the City's transportation network; and"

"That the City Manager, or designee, shall establish a Vision Zero Task Force comprised of external stakeholders and representatives from relevant City departments to be engaged in supporting the development and implementation of a comprehensive Vision Zero Action Plan."
