## CITY COUNCIL WORK SESSION MINUTES AUGUST 29, 2022 COUNCIL CHAMBERS, CITY HALL AND VIRTUALLY 9:05 A.M.

The City Council of the City of El Paso met at the above place and date. Meeting was called to order at 09:29 a.m. Mayor Oscar Leeser was present and presiding and the following Council Members answered roll call: Alexsandra Annello, Cassandra Hernandez, Joe Molinar, Isabel Salcido, Claudia Rodriguez and Henry Rivera. Late arrival: Peter Svarzbein at 10:14 a.m. Cissy Lizarraga requested to be excused.

1.	Presentation and discussion by the COVID-19 Response and Recovery Cross-Functional Team providing information on key activities, efforts, and processes.

1. Overview (Tommy Gonzalez)

Mr. Tommy Gonzalez, City Manager, began the presentation by explaining that according to the Center for Disease Control and Prevention (CDC), the City was classified as "medium", however, the classification should be "high" according to the number of cases per 100,000 currently at 235. Mr. Gonzalez stressed the importance of taking precautions to eliminate the spread of the virus and highlighted the proven effectiveness of vaccinations and boosters against severe illness and death. He continued by listing the location and hour of operation of the City's clinics and stated that the City continues to lead the state and the nation in the number of vaccinated individuals among the community.

Ms. Josette Flores, Senior Assistant City Attorney, reported that the City was in a holding pattern in regard to the mask mandate litigation pending in the  $4^{th}$ ,  $5^{th}$  and  $8^{th}$  Texas Courts of Appeal.

- 3. Team Lead Report: a) Health Focus (Hector Ocaranza, M.D.)
  - i. COVID-19 update
  - ii. Upcoming Flu season
  - iii. Monkeypox Update

Dr. Hector Ocaranza, Public Health Authority, continued the presentation by explaining that the community level in El Paso was high due to the increase in cases as a result of the back to school season. As far as hospitalizations, Dr. Ocaranza said the numbers were reaching a plateau and announced a new Bivalent vaccine that is set to provide protection against new Omicron subvariants such as the BA.4 and BA.5 which are predominantly responsible for new cases. He provided information on the flu season campaign which would take place between September and October via social media, billboards and pop up events. Dr. Ocaranza ended his update by providing information related to the Monkeypox virus with only one confirmed case in the City.

4. City Manager Wrap-up (Tommy Gonzalez)

Mr. Gonzalez wrapped up the presentation by saying that the City would plan for a Monkeypox vaccine rollout, continue to promote a Live Active El Paso lifestyle, and asked the community to sanitize and wear masks if exposed or infected with COVID-19.
