Complete Streets - Update



- Policy Adopted June 16, 2022
- Technical Review Committee First Meeting
 - TRC Members provided roles and responsibilities
 - TRC Members reviewed and voted to carryover responsibilities to MAC
- Per policy, within 90 days of policy adoption, CID, SAM, and P&I, in consultation with the Technical Review Committee, shall draft enabling policy that creates the new Mobility Advisory Committee and clearly defines the roles, responsibilities, and makeup of the committee. This document will also describe how the TRC will interface with the MAC.

Mobility Advisory Committee Recommendation



MAC Membership

- 18 Members Total
- 2 MAC members per Representative District
- 2 MAC members City-wide
- 2-year terms, 2 term limit, no holding over past 30 days

MAC Selection

- Members will be selected by the TRC
- Call for applications
- TRC Committee Chairs will shortlist interested prospective members
- TRC Committee votes on final membership

MAC and TRC

The MAC will appoint a member to serve on the TRC



Mobility Advisory Committee Responsibilities



- MAC serves as resource to TRC, not advisory committee to council.
- MAC will meet at least quarterly
 - Focus on implementation
 - Review of standards and methodologies
 - No review of responsibilities related to individual projects program level input



TRC & MAC Interface



- TRC will provide support for the MAC
 - Prepare Agendas
 - Updates on the status of CS Policy Implementation
- MAC will appoint one of its members to serve on TRC
- TRC will prepare an annual report for the MAC



Recommendation & Next Steps



• Staff recommends the Bicycle advisory committee is allowed to sunset as the MAC will serve a similar function.

 The MAC enabling policy as presented is consistent with the CS Policy and intent.

 - CID will work with PIO to develop an outreach strategy for applicants
 - TRC to review applications
