The City of El Paso receives Federal Entitlement Funds allocated by the U.S. Department of Housing and Urban Development (HUD) on an annual basis.

These funds are intended to revitalize neighborhoods by providing for **decent housing, suitable living environments, and economic opportunities** for low- and moderate-income individuals and families.

Projected 3-Yr Total - \$11.25M		



- Approximately \$3.75 million available citywide each year (Minimum \$1M per project)
- Projects may be funded in phases across more than one year.
- Preliminary results from the **2022 Community Needs Assessment** indicate that projects addressing the following priorities should receive bonus points in proposal evaluation.



\* The 2022 Community Needs Assessment has been completed with the full report projected to be published in early spring 2023 in concert with the Community Health Assessment.

#### **Eligible Applicants**

- Non-profit organizations with facilities located within El Paso
- City of El Paso Departments (Members of City Council are encouraged to coordinate with departments on project proposals)

# **CDBG Public Services**

#### Projected \$925,000 available in 2023-2024 for priority services

Services must align with priorities identified in the 2022 Community Needs Assessment



#### **Eligible Applicants**

Non-profit organizations providing services within El Paso

**City of El Paso Departments** 

Due to limited funding, programs that address multiple priorities and impact multiple vulnerabilities will be prioritized for funding

## **Emergency Solutions Grant**

#### Projected \$542,579 available in 2023-2024 for homeless services

#### ESG Service Components (Projected % of funding)

- Emergency Shelter (15%)
- Street Outreach (25%)

- Rapid Rehousing (26%)
- Homeless Management Information System (7%)

Projected \$704,106 available in 2023-2024 to address the housing needs of persons living with HIV/AIDS and their families
