WHEREAS, the Agreement may be amended under the provisions of Section 4 of the Agreement; and

WHEREAS, the parties desire to extend the duration of the agreement to allow CONTRACTOR to continue to provide the contracted services.

NOW THEREFORE, in consideration of the mutual promises set forth in this 1st Amendment and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

- 1. Section 2 of the Agreement is amended to add the following:
 - 2.1 The services of Contractor are extended beyond the initial term, including options, for an additional 4 years, to terminate April 13, 2027.
- 2. All terms and conditions of the Agreement and all subsequent Amendments thereto, except as herein revised, shall remain in full force and effect.
