April 5, 2023

The undersigned was advised by Unit Commander Cmdr. Motor to meet with the City's Chief Auditor at City 2. The undersigned was advised that incident involved a city employee that is alleged to have stolen gasoline.

The undersigned met with Chief Auditor Edmundo Calderon, his staff Kay Gamboa, Esmeralda Herrera, Miguel Montiel, Daryl Olson and City Representative Brian Kennedy. Mr. Kennedy advised the reason he was at the meeting was that he is the Chairman of the Financial Oversight and Audit Committee (FOAC).

Mr. Calderon advised that it is his job to run audits on any number of items relating to the City. Sometime in November of 2022 after the election he received an anonymous tip on the 1-800 line alleging the outgoing District 3 Representative Claudia Rodriguez had used her City issued fuel card while campaigning. Mr. Calderon stated that he decided to run an audit on the issued gas cards to all members of City Council. Mr. Calderon stated that his review showed two individuals whose usage was significantly above the other members. Mr. Calderon advised the former City Representative for District 6 Claudia Rodriguez and current City Representative for District 3 Cassandra Hernandez fuel usage was significantly above the other members of City Council.

The undersigned was provided with paperwork detailing the times and locations for fuel purchases by the aforementioned individuals. The undersigned was also given a copy of the City of El Paso's administrative policy concerning this specific issue which is the Commercial Fuel Card Policy and Use Procedure (ALON) originally issued July 5, 2021 and revised June 21, 2022.

Mr. Calderon stated that he had a meeting scheduled for April 10, 2023 with City Representative Hernandez to go over the issue. Mr. Calderon advised the undersigned that the meeting could be postponed if it interfered with the investigation. The undersigned advised Mr. Calderon that he should go on business as usual. The

April 10, 2023

The undersigned received a phone call from Mr. Calderon stating that he had decided to postpone his meeting with City Representative Cassandra Hernandez.

The undersigned reviewed all surveillance footage obtained.

April 11, 2023

The undersigned after having reviewed the details of the case and the policy guiding the fuel card could not find that they met the elements to any offense, specifically Misapplication of Fiduciary Funds, Credit Card Abuse or Theft. The main issue being that the parties issued the cards were given little guidance as to their use and there is no documentation stating such.

The undersigned staffed the case without sharing details of the identities of the parties involved with detectives of the Financial Crimes Unit to ensure that nothing was overlooked and the detectives in FCU came to the same conclusion.

The undersigned staffed the case with ADA Doug Tiemann and briefed him on all the known details of the case. ADA Tiemann advised that as the case stood right now if presented he would decline the case citing reason #14 does not meet the elements of an offense.

April 12, 2023

The undersigned briefed Cmdr. Moton, Chief Talamantes, Chief Pacillas and Deputy City Manager Mario D'Agostino on the details of the case.

April 13, 2023

The undersigned requested and obtained a CLEAR report. Through the report the undersigned learned that the Ms. Hernandez has a 2020 Honda Odyssey white in color that matches the vehicle observed in the surveillance footage and Mr. Jordan has a 2022 Toyota Tacoma gray in color that matches the vehicle observed in the surveillance footage.

April 17, 2023

The undersigned met with Cmdr. Moton and staffed the case with him. The undersigned advised him that after reviewing the City of El Paso's administrative policy concerning this specific issue which is the Commercial Fuel Card Policy and Use Procedure (ALON) originally issued July 5, 2021 and revised June 21, 2022 the undersigned could find no provision in which any employee of the City or member of City Council could use the card to fuel a personally owned vehicle. The policy specifically states in Section 3 Fuel Card Purpose – "Fuel cards will be restricted to purchase fuel for the city vehicle to which they are assigned. A fuel card is not to be used for personal vehicles, other city vehicles for which the card is not assigned or rental vehicles. To ensure that the undersigned had not overlooked anything the undersigned contacted Albino Gonzalez Jr, City Fleet Manager, and asked him if there were any provisions that would allow the use of Commercial Fuel Card to fuel a personal vehicle and he stated absolutely not, the policy was very clear on that. The undersigned then advised the Cmdr. Moton that members of City Council should have never received the cards and that any guidance that was given to them as far as the use of the cards was not covered by any policy. Cmdr. Moton instructed the undersigned to schedule a meeting with Mr. Calderon and he wanted to be in attendance.

The undersigned called Mr. Calderon and requested a meeting with him and advised him that Cmdr. Moton would be at the meeting as well. Arrangements were made to meet on 04/18/23 at 0900 hours at City 2 at Mr. Calderon's office.

April 18, 2023

The undersigned and Cmdr. Moton arrived at City 2 and met with Mr. Calderon, Elizabeth De La O and Daryl Olson. Mr. Calderon advised the undersigned that he received new information that Ms. Hernandez was in Vancouver on City travel and that her fuel card was used twice while she was out of town and that her card was used to purchase fuel in Carlsbad, New Mexico as well. The undersigned requested that he send the information to him to include with the case. The undersigned advised Mr. Calderon that he had spoken to Albino Gonzalez, City Fleet Manager, and that he had advised that the fuel cards in question should not have been issued to fuel personal vehicles they were to be used only in conjunction with City vehicles. Mr. Calderon stated that he knew that and stated that the policy was flawed.

The undersigned along with Cmdr. Moton briefed Chief Talamantes on the case.

The undersigned reached out to ADA Doug Tiemann and went through the details again and this time was able to point out that the fuel card in question was issued out in violation of the policy as it is written. That any guidance given on the use of the card to fuel anything except an assigned city vehicle would have been wrong information and any guidance would constitute a violation of the listed policy. ADA Tiemann advised that the incident still did not rise to the elements of any crime.

The undersigned will close out this case a UNFOUNDED as the details do not meet the elements of any offense.
