Project Scope

The scope of work for the Project consists of a Shared Use Path (SUP) with signage, ADA curb ramps and safe crossings at intersections. Project will extend parallel to Magoffin Ave. Magoffin is a three-lane street that will require a road diet for a final cross section of two lanes of traffic. Road diet will allow the construction of the proposed shared use path, while maintaining parking within the limits of the project.

- Shared Use Path (SUP) within the project limits.
- ADA ramps
- Intersection pedestrian signal improvements at Cotton St.
- Driveways
- Relocations are expected, street illumination

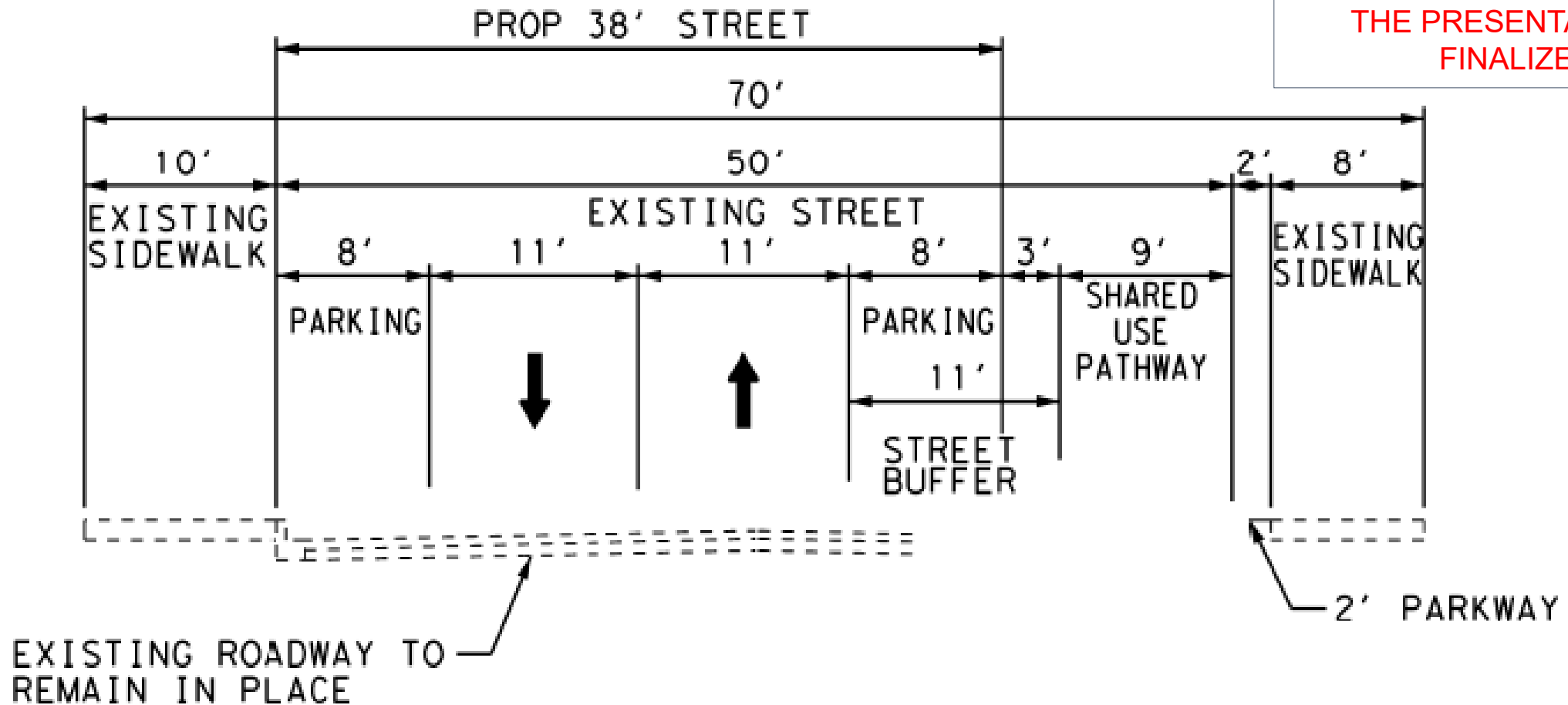

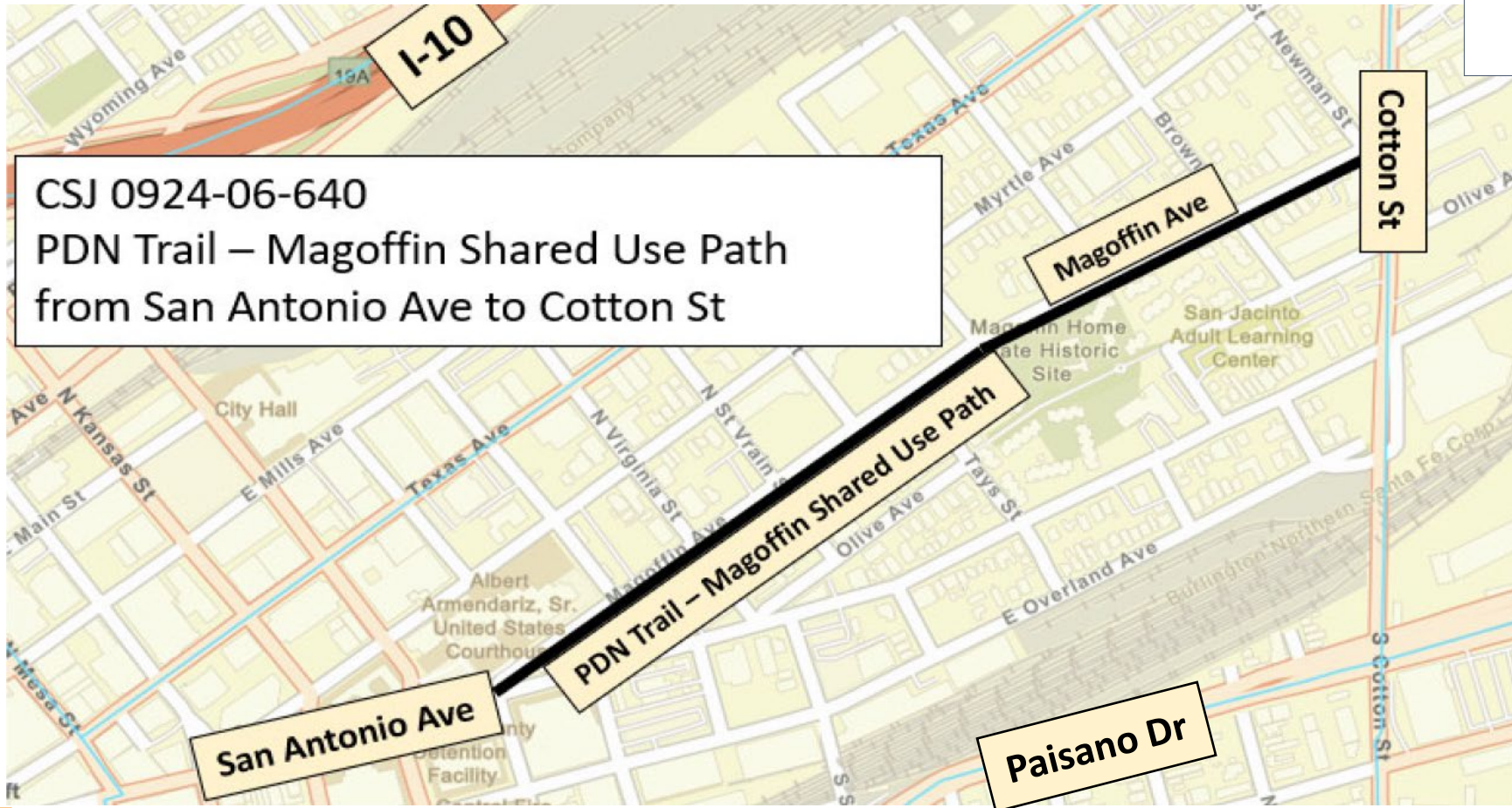

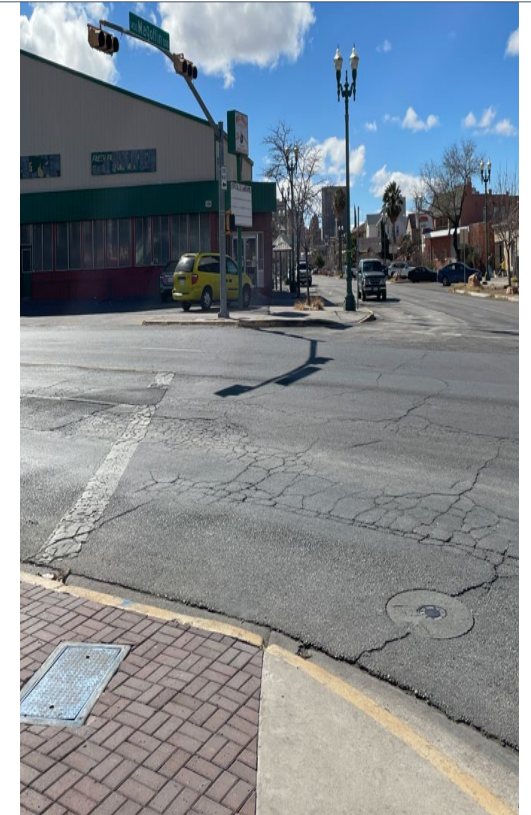
