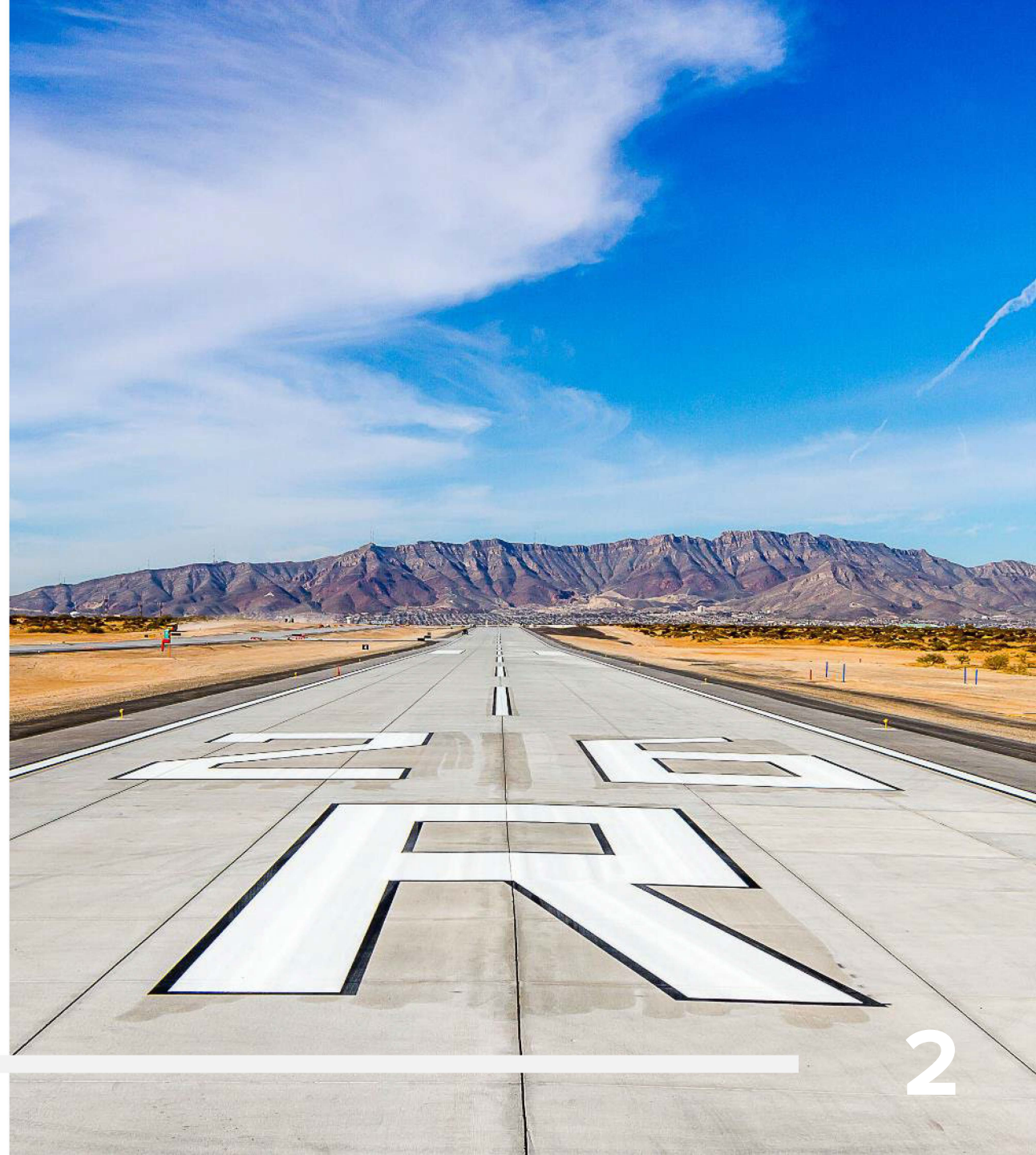
# EL PASO INTERNATIONAL AIRPORT

# What Is Turo

- Turo is a peer-to-peer car sharing company.
- It allows car owners to list their personal vehicles for rent on the platform.
- Peer-to-Peer Car Sharing means the authorized use of a Vehicle by an individual other than the Owner through the Operator's Platform.



# Turo Services

- **Insurance Coverage:** Turo provides insurance options for both car owners and renters, helping to ensure that both parties are protected in case of accidents or damage during the rental period.





# Turo Services Continued

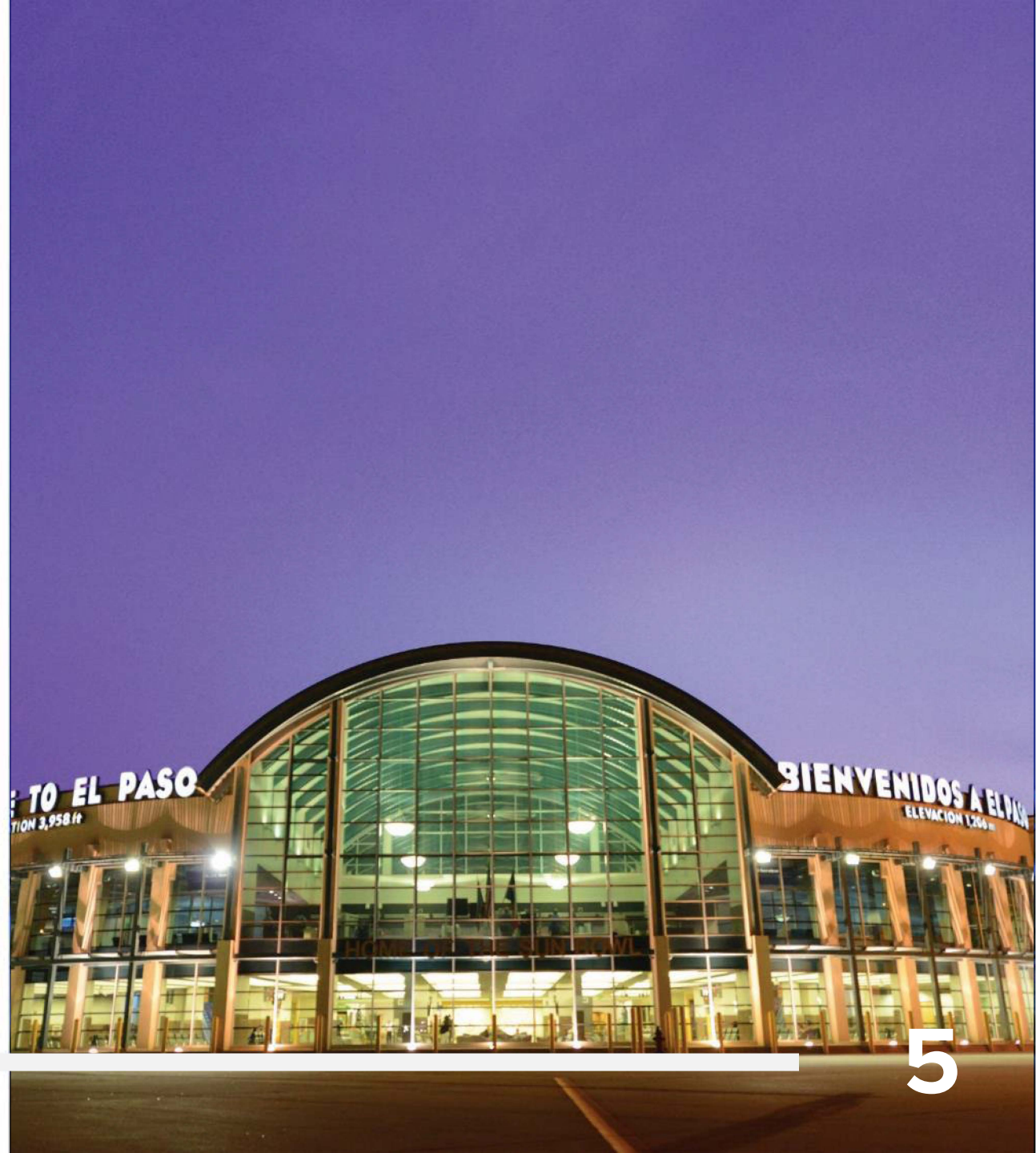
- **Mobile App:** Turo offers a mobile app for access to its services, allowing users to search for and book vehicles on the go.
- **Airport Locations:** Turo has partnerships with several airports, allowing travelers to rent a car upon arrival, offering an alternative to traditional rental car services.



# Agreement and Terms

## FEES

- Ten percent (10%) of Turo's Gross Receipts.
- Turo will submit a statement of its gross receipts within fifteen (15) calendar days after the close of each calendar month.





# Agreement and Terms

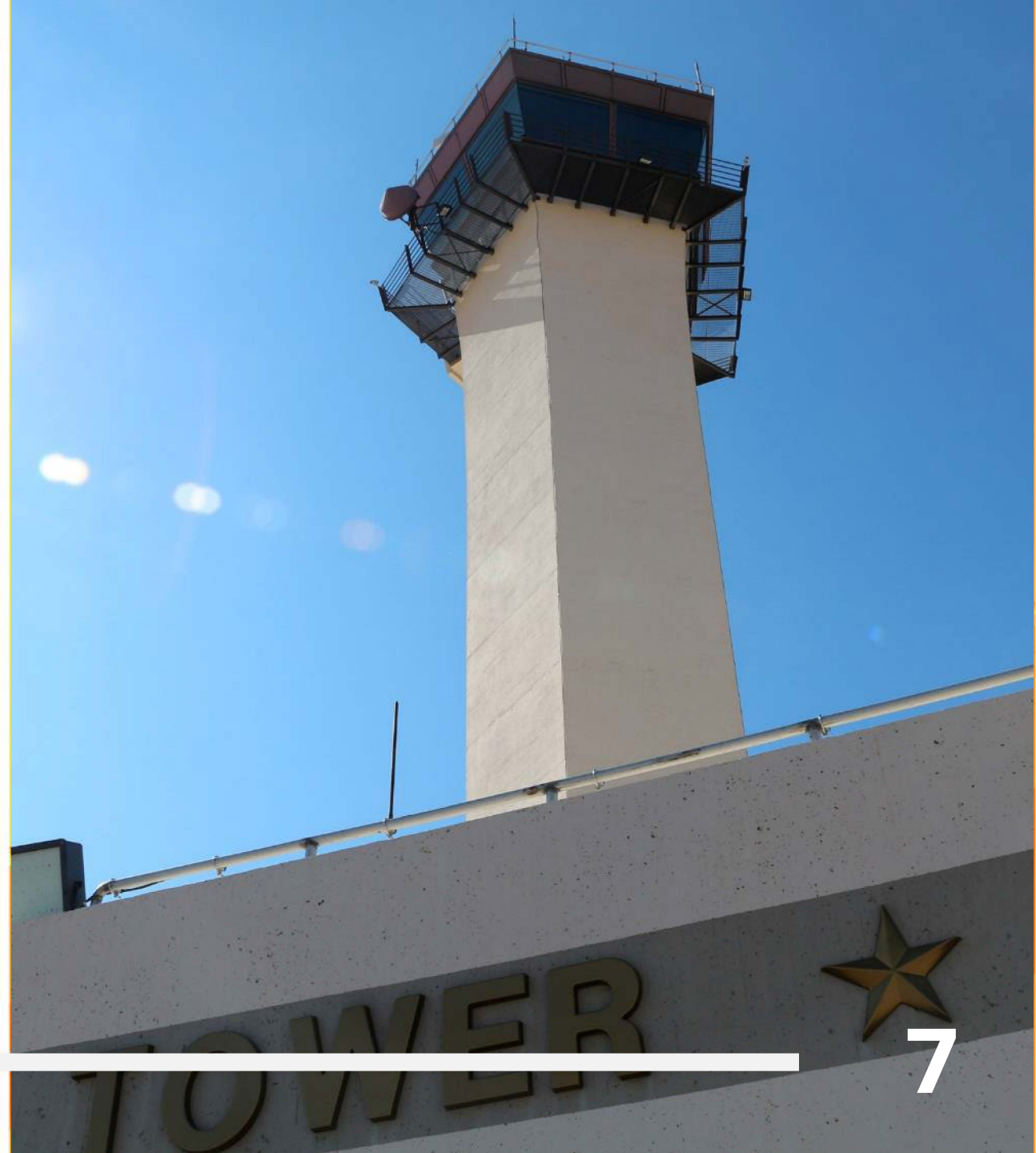
## Term

- The agreement will be in effect for a period of one (1) year
- The agreement includes 4, 1-year extensions.
- Either Party may terminate the license agreement, at any time, for any reason, with thirty (30) days written notice.



# Agreement and Terms

- **Operational Terms**
- Turo will be granted the non-exclusive and revocable right to operate at the Airport under the trade name Turo.
- The Airport public parking lots will be the designated area for vehicle pickup or drop-off.
- Turo must comply with all applicable local, state, and federal laws.



# Agreement and Terms

## Requirements

- Turo shall: Ensure that all Owners have a valid driver's license and all vehicles made available through the Platform at the Airport meet all insurance requirements
- Conduct background screenings on all the Owners

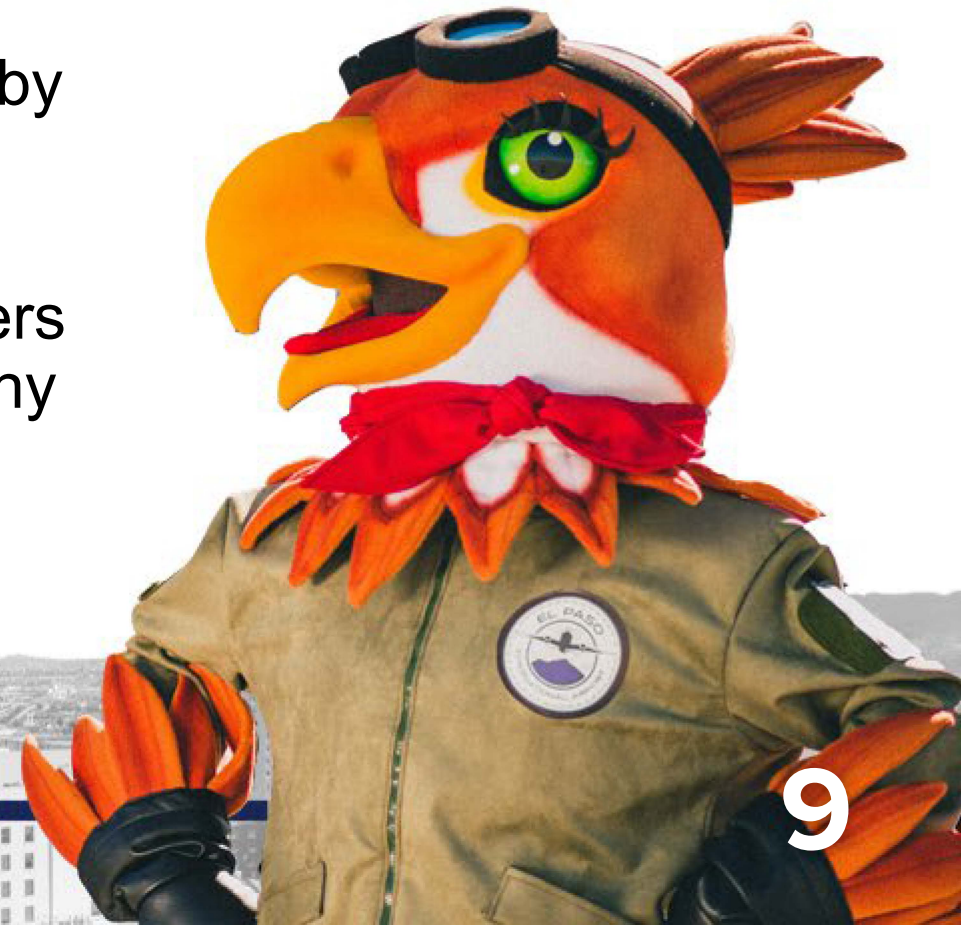




# Agreement and Terms

## Requirements Continued

- Evaluate the safety of Vehicles made available by Owners by checking VINs for safety recalls and determining whether the title is branded
- By operating on the Airport, Operator and Owners shall be subject to Applicable Laws, including any fines or penalties in connection therewith.



# Agreement and Terms

## Recommendations

- Approve license agreement to capture peer-to-peer rentals already taking place at the airport.
- Have a baseline agreement for new peer-to-peer rentals that will operate out of the airport.
