Contract Scope of Work (continued)



The services will include but are not limited to the following:

- Professional engineering services in the field of geotechnical and materials testing.
- Provide technical and professional engineering consultation for geotechnical investigations and related laboratory testing services including labor, equipment and materials for the projects.
- Provide materials engineering and testing, and construction quality assurance / quality control (QA/QC) services.
- Provide the City a monthly report of tasks and activities related to this service. Report should include project name, percent of testing completed, number of invoices paid, total amount of purchase order and report failures.
- Provide virtual depository to host all testing reports.
- Provide only those services which lie within the technical and professional areas of expertise which the firm is adequately staffed and equipped to perform. The firm shall be experienced and able to demonstrate the certifications, equipment, and ability to perform all necessary services.
