RESOLUTION

WHEREAS, the proposed Borderland Expressway Project (the Project) is a bistate project that consists of the upgrade of NM 404 and NM 213 to four-lane divided highways and the construction of a new four-lane highway from the Texas/New Mexico State line to Loop 375 in Northeast El Paso; and

WHEREAS, the City of El Paso has expressed it support for the Project and also recognizes that the use of pass-through financing was a highly successful funding approach for the area's State Spur 601 (Inner Loop) Project and that this financing approach was presented to the Texas Department of Transportation as a potential funding source for the Project; and

**WHEREAS**, the City of El Paso recognizes that the anticipated Project budget is in excess of \$300 Million and that all available traditional and innovative funding sources

and financing mechanisms, including specifically pass-through financing, should be pursued in order to develop this important regional project; and

**WHEREAS**, the development of the Project furthers the City of El Paso's strategic goal to enhance and sustain El Paso's infrastructure network.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

**THAT** the City of El Paso hereby expresses its support for the use of pass-through financing from the Texas Department of Transportation, as one of the sources to be used in the development of the Borderland Expressway Project.
