

# Statewide Mask Mandate Litigation Texas Supreme Court Oral Arguments

- On February 22, 2023, Texas Supreme Court heard oral arguments on four similar cases including Abbott v. San Antonio, and Abbott v. Clay Jenkins
- The Court considered the limits of the governor's authority under the Texas Disaster Act
- Court requested parties submit supplemental briefs
- No ruling has been issued





# Additional Updates- Federal Emergency Declaration

- HHS announced its decision to allow the public health emergency to expire on May 11, 2023.
- Consequently, the Title 42 litigation will be moot
- The U.S. Supreme Court has removed previously scheduled Title 42 litigation from its oral arguments calendar







# Texas Supreme Court Final General Emergency Orders Regarding the COVID-19 State of Disaster

- On January 27, 2023, the Texas Supreme Court issued its Final General Emergency Order Regarding the COVID-19 State of Disaster
  - Continues allowing courts to use reasonable efforts to conduct proceedings remotely
  - Effective as of February 1, 2023 and remains until March 1, 2023



# COVID-19 Update


- Federal Public Health Emergency set to expire on May 11, 2023
- Currently at Low Community Level
- New Cases per 100,000 steadily in decline, have improved by over 40% from January
- New Hospital admissions have decreased by over 70% since the peak in January
- Percent of occupied staffed beds caring for COVID-19 patients dropped by over 50% from January peak
- Strongly recommend and encourage people to get the bivalent booster as a way to prevent hospitalization

























- Influenza activity is steadily decreasing across the country, state and our community
- Influenza A continue to be the predominant type
- As respiratory virus activity decline, Hospitals have not been constrained and are able to care for patients with other conditions through available staffed beds












## AN EMERGENCY ORDINANCE RE-ENACTING EMERGENCY ORDINANCE NO. 019035 EXTENDING A DISASTER DECLARATION DUE TO A PUBLIC HEALTH EMERGENCY

**WHEREAS**, on March 13, 2020, the Governor of the State of Texas declared a state of disaster and the President of the United States of America declared a national emergency in relation to COVID-19; and

**WHEREAS**, on March 13, 2020, the Mayor signed a Local Emergency Declaration and requested the aid of the State Government pursuant to Texas Government Code Section 418.108; and

**WHEREAS**, pursuant to El Paso City Code Section 2.48.020(C), a local state of disaster declaration may not be continued or renewed for a period in excess of seven days except by or with the consent of City Council; and

**WHEREAS**, City Charter Section 3.10 allows for the City Council to adopt an emergency ordinance to meet a public emergency affecting life, health, property or the public peace; and

**WHEREAS**, on March 17, 2020, the City Council adopted Emergency Ordinance No. 019035, Extending a Disaster Declaration Due to a Public Health Emergency; and

**WHEREAS**, since March 2020, El Paso City Council has re-enacted Emergency Ordinance No. 019035 monthly, with the most recent re-enactment taking place on January 30, 2023; and

WHEREAS, despite local COVID-19 cases continuing to decline, the risk of contracting COVID-19 remains and new variants of the virus are expected to arise; and

**WHEREAS**, as of February 13, 2023, the number of new COVID-19 active cases reported in El Paso is 152 and the cumulative number is 310,349; and

**WHEREAS**, pursuant to City Charter Section 3.10, every emergency ordinance shall stand repealed automatically as of the 31<sup>st</sup> day following the date on which it was adopted, but may be re-enacted to continue a Disaster Declaration; and

**WHEREAS**, Emergency Ordinance No. 019428 which re-enacts Emergency Ordinance No. 019035 is set to expire on March 1, 2023;

WHEREAS, the condition necessitating a declaration of a state of disaster continues to exist.

### NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF EL PASO, TEXAS:

- 1. That the state of disaster proclaimed for the City of El Paso by the Mayor on March 13, 2020, and extended by Emergency Ordinance No. 019035, is hereby re-enacted and shall continue for thirty (30) days unless re-enacted in accordance with City Charter Section 3.10 or until terminated by City Council, whichever is sooner.
- 2. This ordinance is adopted as an emergency measure with the unanimous vote of the City Council Representatives present and the consent of the Mayor and pursuant to City Charter Section 3.10.



Prior to the convening of each biennial State legislative session, the City Council of the City of El Paso identifies policy priorities and legislative initiatives that it would like the Texas Legislature to address during its legislative session. These priorities and initiatives are adopted and compiled into the City's Legislative Agenda which is shared with the City's legislative delegation and additionally used to guide staffs' activity during the legislative session. The City's legislative agenda was finalized on November 7, 2022 and the 88th legislative session began on January 10, 2023. This will be the second update on the session to go over key items and bills that are of interest to the City.

This will be the first update on our federal legislative agenda and federal appropriations opportunities.

#### PRIOR COUNCIL ACTION:

City Council adopts a Legislative Agenda for each biennial State legislative session and receives regular updates from City staff on legislative activity during the State's regular and special sessions. City Council received a legislative briefing to initiate this process on May 9, 2022, and received an update on August 16, 2022, where the legislative priorities were approved. On October 25, 2022 City Council approved a majority of the Support/Oppose Section, and on November 7, 2022 the Legislative Agenda was finalized. On January 30th, City Council took action to support and/or oppose three filed bills.




## Rides Per Day of the Week







#### **Overview**



- Streets are our community's most valuable asset
  - Total system valued at more than \$3B (based on industry estimates)
- City is catching up on years of deferred maintenance
  - Goal is to decrease the investment gap from years of neglect
- Current City budget is \$13.5M per year for street improvements
- Average City street PCI is rated below fair condition
  - Means the street is weathered, cracking, or in dire need of repair
- A budget of at least \$44M is needed <u>every</u> year to get and keep streets in satisfactory or better conditions
  - Streets need ongoing repairs



#### City Pavement Management Overview



- Original construction of a street is normally performed by developers (Developer's cost)
- Upon acceptance, the street right-of-way assets are added to the City inventory for maintenance
  - This includes streets, medians, lighting, signage, and markings
- The expected useful life of a new street is 25 years; there are factors that can expedite deterioration:
  - Impact of rainwater and storm events
  - Soil conditions
  - Traffic volumes
  - Improperly restored pavement cuts





- 6,117 streets (within City limits)
- 5,769 residential streets
- 188 arterial streets
- 160 collector streets
- Over 2,400 centerline miles



This does **not** include state highways, county roads, and private streets



#### **Street Selection Process**



Project streets included an emphasis on the following:

- PCI Data from the recent assessment new PCIs drive the selection criteria
- Utility Clearances selected streets were vetted with utility partners to ensure there are no water, gas, or electric line issues that could cause them to be cut into within the next few years
- Geographic Locations wherever possible the focus is on working in neighborhoods, limiting mobilization, and avoiding jumping around the City



- Estimated need of \$170 million for collector streets at present cost




