RESOLUTION

WHEREAS, on August 15, 2023 the Mass Transit Department Board ("MTB") of the City of El Paso approved the Fiscal Year 2024 Budget for the Mass Transit Department by Resolution ("MTB Budget Resolution"); and

WHEREAS, the MTB desires to amend paragraph 27 of the MTB Budget Resolution to allow the City Manager or designee, to waive fares for bus service for a maximum of ten (10) days per fiscal year, for city designated holidays and events from September 1, 2023 through August 31, 2024.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF THE MASS TRANSIT DEPARTMENT OF THE CITY OF EL PASO:

- 1. That paragraph 27 of the MTB Budget Resolution is amended to read as follows:
 - 27. To allow the City Manager or designee, to waive fares for bus service for a maximum of ten (10) days per fiscal year, for city designated holidays and events.
- 2. FY2024 SCHEDULE B MASS TRANSIT DEPT. FARE AND FEE SCHEDULE is revised as reflected in Attachment A to this amending Resolution.
- 3. Address minor scrivener's errors to conform with the intent of the Resolution, including the correction of FY2024 references.
- 4. Except as amended herein, the MTB Budget Resolution shall remain in full force and effect.
